Commence at the NE corner of the above said SE $\frac{1}{4}$ -NE $\frac{1}{4}$ and in a Westerly direction along the North line of said quarter-quarter, run a distance of 1263.0 feet; thence, turn an angle of 102°03' to the left for a distance of 294.72 feet, to the point of beginning; thence, continue along the same said course for a distance of 70.70 feet; thence, turn an angle of 1°46' to the right for a distance of 100.65 feet; thence, turn an angle of 20°55' to the right for a distance of 139.23 feet; thence, turn an angle of 22°00' to the right for a distance of 48.17 feet; thence, turn an angle of 27°48' to the right for a distance of 63.40 feet, to the easterly right of way line of U.
