KNOW ALL MEN BY THESE PRESENTS,


That in consideration of Thirteen hundred and twentyfive and No/100 DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEEES herein, the receipt whereof is acknowledged, we, Jessie Marie Brandenb^{ur}g and husband, Homer L. Brandenb^{ur}g

(herein referred to as grantors) do grant, bargain, sell and convey unto
Billy Morris Frestridge, and wife Dorothy Ann Steele Frestridge

(herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Lct 2, in Block 1, of First Addition to Bell Acre Subdivision in Map Book 4, Page 77 in the Probate Office of Shelby County, Alabama, situated in and being a part of the S^W 1/4 of the S^W 1/4 of Section 2, Township 21 South, Range 3 West, Shelby County, Alabama.

Subject to restriction as follows: " all lots are for residential purposes only, and dwellings shall have a minimum of 1,000 square feet in the main body of the house. No structures of a temporary nature, such as trailers, tents, shacks, basements, garages, or other outbuildings shall be used as a residence either temporarily or permanently "; and this covenant shall attach to and run with the land



TO HAVE AND TO HOLD to the said GRANTEEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEEES, their heirs and assigns forever, against the lawful claims of all persons.
