do we grant, bargain, sell and convey unto the said Arthur Scott and Roxie Scott,  
as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

Commence at the NW corner of Lot No. 2, Block 2, map of Pelham Estates  
as recorded in the Probate Office of Shelby County, Alabama, in Map Book 3,  
page 57, and run thence Southerly along the East side of Pelham Street  
100 feet; thence Easterly and parallel with the North boundary of said  
Lot No. 2, 80 feet; thence Northerly and parallel with the East boundary  
of said Pelham Street 100 feet to the North boundary of said Lot No. 2;  
thence westerly along the North boundary of said Lot No. 2, 80 feet to  
the point of beginning.

TO HAVE AND TO HOLD Unto the said Arthur Scott and wife Roxie Scott

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for our and for their heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances;

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
