

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, _____

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularity described as follows, to-wit: And as shown on the right-of-way map of Project No. SACP as recorded in the office of the Judge of Probate of Shelby County. 4243-A

Beginning at a point on the centerline of Project SACP 4243-A at Station 0+00, being a point in the center of County Road 55; thence in a southwesterly direction along the centerline of said project along a 2° curve to the right a distance of 300 feet to the point of ending at Station 3+00, being a point on the southwest property line.

Said parcel of land being 30 feet wide on the left side from Station 0+00 to Station 2+00; thence 40 feet wide on the said left side to Station 3+00 of said project and is lying in the SE 1/4 of SW 1/4, Sec. 5, T 18 S, R 2 E and contains .23 acres, more or less, including that part now occupied by the present road.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
