County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

particularly described as follows, to-wit: And as shown on the right-of-way map of Project No.SACP as recorded in the office of the Judge of Prebate of Sheiby County.

Parcel I. Beginning at a point on the centerline of Project SACP 4243-A at Station 160+90 the northeast property line; thence south 47° 14' West along the centerline a distance of 87' to the point of ending at Station 161+77, the southwast property line.

Said parcel of land being 40' wide on each side of centerline of said project and is lying in the SW 1/4 of SE 1/4, Sec. 11, T 18 S, R 1 E and contains .16 acre more or less, including that part now occupied by the present road.

Parcel II. Beginning at a point on the centerline of said project at Station 162+77, the northeast property line; thence southwesterly along the centerline along a 0°45' curve to the left a distance of 438' to the point of ending of curvature of the centerline; thence south 43° 14' west along the centerline a distance of 57' to the point of ending at Station 167+67, the southwest property line.
