R. Montgomery, who departed this life on or about September 18, 1954 in Jefferson County, Alabama,

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Four Thousand Seven Hundred and No/100 (\$4700.00) DOLLARS, in hand paid to them by the party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, and sold, and by these presents does grant, bargain, sell, and convey unto the said Katherine Montgomery Justice and husband, Herman Bryant Justice as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:

Shrader gin lot, thence South along Highway 231 Right-of-Way 95 feet to the point of beginning of the following described tract of land which is hereby conveyed: thence South along said Highway Right-of-Way 58 feet; thence in a Westerly direction 210 feet to a stake, thence in a Northwesterly direction 121 feet to another stake; thence in an Easterly direction 238 feet to the starting point. Being a part of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 15, Township 19, Range 2 East.

TO HAVE AND TO HOLD unto the said Katherine Montgomery Justice and husband, Herman Bryant Justice as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.




