to have and hold in fee simple, and to be his absolutely.

In the event my beloved husband, James Lee Dorough, should predecease me, or in the event we should die in a common accident or calamity, I do hereby give, devise and bequeath said property described above to my beloved step-son, Ronald Lee Dorough, of Leeds, Alabama.
