THIS INDENTURE, made and entered into on this the 3rd day of January, 1964, by and between Alabama Metallurgical Corporation,

a Delaware corporation qualified to do business in Alabama, hereinafter, referred to as first party, and William C. Chandler and Martha S. Chandler, husband and wife, hereinafter referred to as second party,

WITNESSETH: That for and in consideration of the sum of SEVEN HUNDRED FOURTEEN DOLLARS (\$714.00), cash in hand paid first party by second party, the receipt of which said sum is hereby acknowledged by first party, said first party does hereby grant, bargain, sell and convey unto second party, their heirs and assigns, the following described real estate situated in Shelby County, Alabama, viz:

Beginning at the Southwest corner of the Southwest quarter of the Northwest quarter of Section 33, Township 21 South, Range 3 West; thence run East a distance of 549.38 feet to a 1½ inch iron pipe on the East margin of the Southern Railway right-of-way; thence turn a deflection angle to the left of 77° 29' and run in a Northerly direction along the East margin of the Southern Railway right-of-way a distance of 367.23 feet to a 1½ inch iron pipe on the South margin of a dirt road, said point being the point of beginning of the property herein conveyed; and from said point of beginning turn a deflection angle to the right of 81° 38' 20" and run in an Easterly direction along the South margin of said road a distance of 645.21 feet to a 1½ inch iron pipe on the Western margin of the Montevallo Elyton Public Road; thence turn a deflection angle to the left of 95° 51' and run northerly along the Western margin of said Montevallo Elyton Road a distance of 285.0 feet to a 1½ inch iron pipe; thence turn a deflection angle to the left of 78° 59' 20" and rum Westerly a distance of 569.1 feet to the East margin of the Southern Railway right-of-way; thence turn a deflection angle to the left 87° 47' and run in a Southerly direction along the East margin of the Southern Railway right-of-way a distance of 338.5 feet to the point of beginning; according to a survey dated March 1962, made by Alton Young, Registered Surveyor, Alabaster, Alabama. LESS AND EXCEPT, however, a strip of land of uniform width of 50 feet off the entire South boundary of the above described parcel, which said 50 foot strip is expressly reserved, in fee simple, by first party.

It being intended to convey herein, whether herein correctly described or not, all real property owned by first party which lies East of the Southern Railway right-of-way in the Southwest quarter of the Northwest quarter of Section 33, Township 21 South, Range 3 West, less and except the aforesaid 50 foot strip of land off the entire South boundary thereof;



said real property conveyed containing 3.57 acres, more or less, situated in Shelby County, Alabama.

TO HAVE AND TO HOLD the same unto second party, their heirs and assigns, in fee simple, forever, subject, however, to the above reserved 50 foot strip.

This conveyance is made with the strict understanding and agreement with second party that second party, their heirs, successors or assigns, will in no way disturb or alter the drainage and flow of water across said above described property which will in any way damage or disturb the use of property belonging to first party, its successors or assigns.

First party hereby covenants with second party, their heirs and assigns, that it is lawfully scized of an indefeasible estate, in fee simple, in and to the above described property, and it has the lawful right to sell and convey the same; that said property is free of any and all liens, taxes and encumbrances, whatsvever; and that it, first party, will warrant and forever defend second party, their heirs and assigns, in the quiet and peaceable possession of the same against the lawful claims or demands of any and all persons, whomsoever.
