From the Southeast corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 11, Township 18 South, Range 1 East run Northerly along the East boundary line of the said SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Sec. 11, Twp. 18 S., R1E, for 208.71 feet; Thence turn an angle of 91 Degrees, 14 Minutes, 15 Seconds to the left and run Westerly 417.42 feet; Thence turn an angle of 53 Degrees, 33 Minutes to the right and run Northwesterly 241.34 feet to the point of beginning of the land herein described; Thence turn an angle of 90 Degrees, 30 Minutes to the left and run Southwesterly 145.57 feet; more or less, to a point on the East Right-of-Way line of Alabama State Highway No. 25; Thence turn an angle of 121 Degrees, 51 Minutes to the right and run Northwesterly along the East R.O.W. line of Ala. 
