the receipt whereof is acknowledged by the said C. B. Burnett and wife Norma Lee Burnett

do grant, bargain, sell and convey unto the said Cecil Motes and wife Bonnie Motes

as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

From the Northeast corner of the South Half of the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 18, Township 20 South, Range 2 West run Southerly along the East boundary line of the said S $\frac{1}{2}$  of the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Sec.18, Tsp.20S., R.2W. for 616.52 feet to a point in the center of a dirt road; Thence turn an angle of 102 Degrees, 43 Minutes to the right and run Northwesterly along the center of said dirt road for 292.5 feet; Thence turn an angle of 05 Degrees, 49 Minutes to the left and continue Northwesterly along the center of said dirt road 68.7 feet to the point of beginning of the land herein described and conveyed; Thence continue Northwesterly along the center of said dirt road for 210.0 feet to a point on the center line of the Fungo Public Road; Thence turn an angle of 105 Degrees, 45 Minutes to the right and run Northeasterly along the center of said Fungo Public Road for 110.0 feet; Thence turn an angle of 74 Degrees, 15 Minutes to the right and run Southeasterly for 210.0 feet; Thence turn an angle of 105 Degrees, 45 Minutes to the right and run Southwesterly 110.0 feet to the point of beginning.

This land being a part of the S $\frac{1}{2}$  of the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 18, Township 20 South, Range 2 West, and being 0.50 acres, more or less.

EXCEPTING However, from the above described land the Right of Way of the Fungo Public Road as now located.

TO HAVE AND TO HOLD Unto the said Cecil Motes and wife Bonnie Motes

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances;

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
