ASSIGNMENT OF MORTGAGE

(By United States as Trustee to United States for Itself)

WHEREAS, the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, for itself, herein called "Assignee," whose post office address is Washington, D. C., has become the holder of said note or bond, and by virtue thereof has acquired the beneficial as well as legal title to said mortgage in its own right, and it is desired to show of record such transfer of title.

NOW; THEREFORE, for value received, the Assignor does hereby assign, transfer, convey and set over unto the Assignee the said mortgage and all right, title and interest of the Assignor in the property described therein, to have and to hold the same unto the Assignee and its assigns.
