KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED (\$100.00) DOLLARS, and other good and valuable considerations, to the undersigned grantors, N. H. WATERS, JR., and his wife, ELAINE C. WATERS, in hand paid by SERGIO DAVILA, the receipt whereof is hereby acknowledged, we, the said N. H. WATERS, JR. and wife, ELAINE C. WATERS, do

GRANT, BARGAIN, SELL and CONVEY unto the said SERGIO DAVILA, the following described real estate, situated in Shelby County, Alabama:


All of the South One-half of Section 15 which lies east of Shoal Creek and all of the Northeast Quarter of Section 22 in Township 22, Range 3 West. Said property containing 345 acres more or less.
