as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

Commence at the northwest corner of SW $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 27, Township 19 South, Range 2 East and run east along the north line of said forty acres 375.6 feet to the point of beginning of the lot herein conveyed; thence run south, 19 degrees 58 minutes east, 244.2 feet; thence north, 69 degrees 26 minutes east, 105.8 feet; thence north, 30 degrees 43 minutes west 227.2 feet to said forty acre line; thence along same west, 66 feet to the point of beginning,

EXCEPTED, however, from the above described real estate and not conveyed by this instrument and reserved in fee simple by the grantors herein is the following described real estate:

Begin at the northwest corner of the southwest quarter of the northwest quarter of section 27, township 19 south, range 2 east and run east 375.6 feet to the point of beginning; thence continue east for a distance of 66 feet; thence run south 30° 43' east 105 feet; thence run south 57° west 75.5 feet; thence run north 20° west 148 feet to the point of beginning. TO HAVE AND TO HOLD Unto the said Calvin Davis and wife, Lonia W. Davis

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances;

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
