KNOW ALL MEN BY THESE PRESENTS; That HELENA BAPTIST CHURCH, for and in consideration of the sum of ONE 00/100 Dollars (\$ 1.00), to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power, with the right to string thereon from time to time, electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers, upon, under, over, and across the following described land situated in SHELBY County, Alabama:

A PART OF S 1/2 OF SW 1/4 OF SEC. 15, TP. 20, RANGE 3W DESCRIBED AS FOLLOWS;
COMMENCE AT POINT WHERE SOUTH LINE OF FORMER F.F. MULLINS PROPERTY (FORMERLY OWNED BY IDA SMITH) INTERSECTS THE EASTERLY LINE OF MAIN STREET IN THE TOWN OF HELENA, ALA.; THENCE RUN SOUTHERLY ALONG THE EASTERLY LINE OF MAIN STREET 125 FEET; THENCE RUN EASTERLY PARALLEL WITH SOUTH LINE OF SAID F.F. MULLINS PROPERTY 200 FEET; THENCE RUN NORTHERLY, PARALLEL WITH EASTERLY LINE OF MAIN STREET 125 FEET TO SOUTH LINE OF SAID F.F. MULLINS PROPERTY; THENCE RUN WESTERLY ALONG SOUTH LINE OF SAID F.F. MULLINS PROPERTY 200 FEET TO POINT OF BEGINNING -
ALSO A STRIP OF LAND ~~5 FT WIDE~~ ADJOINING THE SOUTH LINE OF ABOVE DESCRIBED LOT, BEING 45 FEET WIDE ON WEST END OF SAID STRIP AND 25 FEET (MORE OR LESS) WIDE ON EAST END AND RUNNING THE ENTIRE LENGTH OF THE SOUTH LINE OF ABOVE DESCRIBED LOT.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines, and also the right to cut and keep clear all trees and to keep clear other obstructions that may injure or endanger said lines.
