

Part of the SN4 of NE4 of Section 21. Township 22 South, Range 3 West described as follows: From the Southwest corner of the SM4 of NE4 Section 21, Township 22 South, Range 3 West, go East along the South line of the said quarter-quarter section for a distance of 40.5 feet to a point of beginning, thence North parallel to the West line of the said quarter-quarter section for a distance of 110 feet, thence East parallel with the South line of the said SW4 of NE4 for a distance of 109.5 feet, thence South parallel with the said West line of the SW4 of NE4 for a distance of 110 feet to the South line of the SW4 of NE4, thence West along the said South line for a distance of 109.5 feet to the point of beginning, situated in the Town of Montevallo, Shelby County, Alabama.



TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
