The Northwest Quarter (NWt) of Section 20, Township 20 South, Range 2 East, except three (3) acres in the Southeast corner, East of Yellow Leaf Creek, situated in Shelby County, Alabama, containing in all 157 acres, more or less. Three-fourths (3/4) interest in the minerals in and under the above described land has heretofore been reserved by the Federal Land Bank of New Orleans and the Federal Farm Mortgage Corporation.
