do grant, bargain, sell and convey unto the said Steve Huchko and Helen M. Huchko

as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

Begin at the Southwest corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 13, Township 20 South, Range 4 West, thence run East along the South line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ a distance of 280.9 feet for point of beginning; at said point of beginning turn left an angle of 51 degrees 49 minutes a distance of 188.34 feet, turn left an angle of 07 degrees 32 minutes a distance of 348.63 feet, turn right an angle of 26 degrees 57 minutes a distance of 256.95', turn left an angle of 102 degrees 44 minutes a distance of 287.09 feet to the center line of Shades Crest Road, turn left an angle of 90 degrees 09 minutes along said center line a distance of 554.14 feet, turn left an angle of 56 degrees 30 minutes 30 seconds a distance of 403.51 feet to point of beginning; except that part lying in right-of-way of Shades Crest Road; being in NW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 13, Township 20 South, Range 4 West, Shelby County, Alabama.

TO HAVE AND TO HOLD Unto the said Steve Huchko and Helen M. Huchko

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantor does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances;

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.

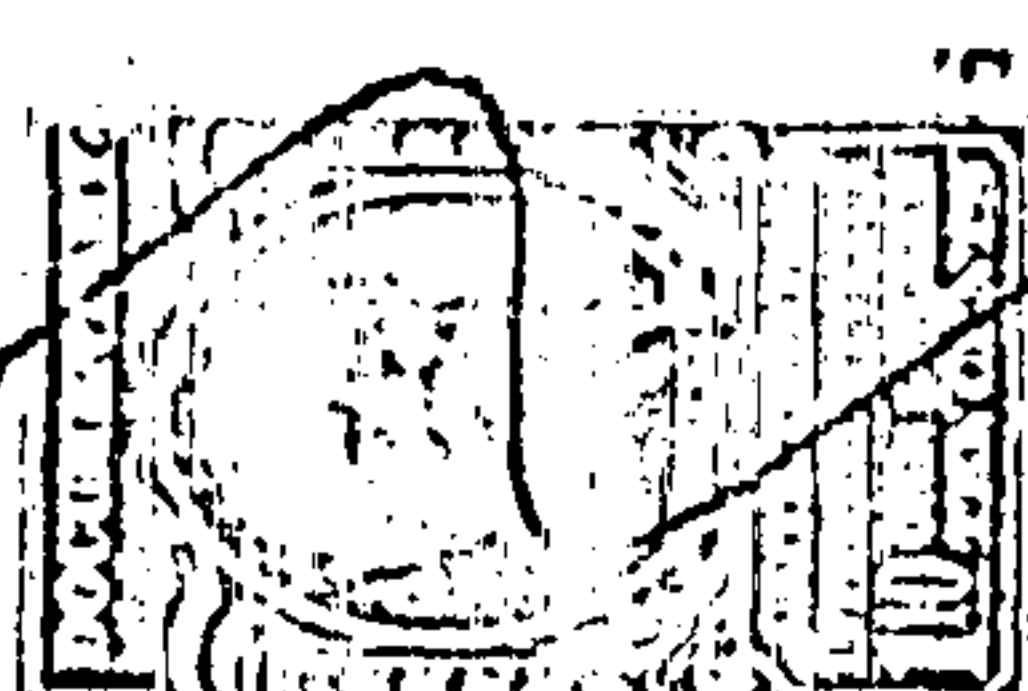
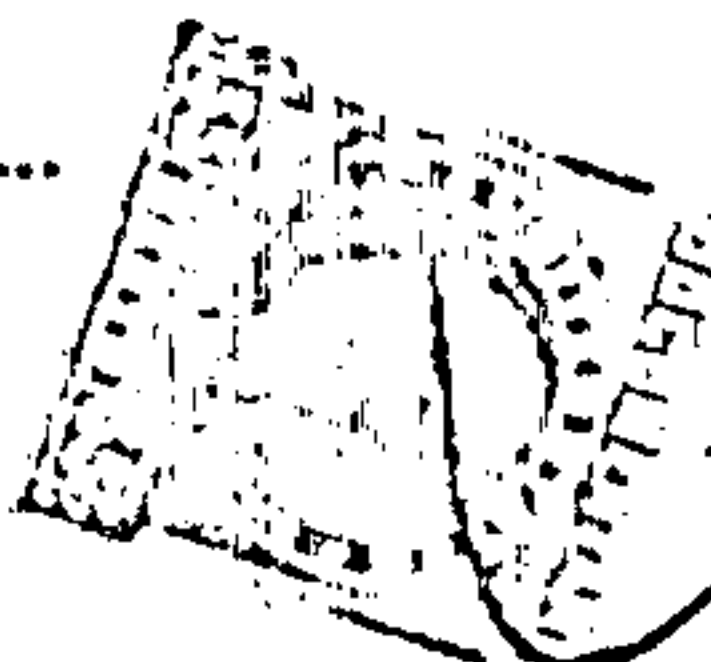
