THE MINUTES OF A SPECIAL BUSINESS MEETING OF MAY 21, 1964, OF THE CHURCH OF GCD OF FROPHECY AT

STERPETT, ALABAMA

A special business meeting of the members of the Church proper of The Church of God of Prophecy at Sterrett, Alabama, an ecclesiastical organization, was held at eleven o'clock, A.M. on Sunday, May 2h, at Sterrett, Alabama, in the place of regular meeting of said Church, being the main auditorum of the sanctuary of said Church, a quorum of said members being present. At said meeting, the Tastor and regular moderator of said Church, the Rev. Alabama, served as moderator, and Brother Jimmy Pay Howard, the duly elected Church Clerk and Treasurer, served as clerk of said meeting.

WHEREUTON the following resolution was introduced by member Brother H.P. Runns.:

"WHETEAS, the Church of God of Prophecy at Sterrett, Alabama, is an ecclesiastical organization and an organized Church having affiliation with the Church of God of Prophecy at Bible Flace, Tennessee, of which K. A. Tomlinson is Ceneral Overseer, and

WHEREAS, it is desirable that certain improvements be made on our parsonage and that in order to finance said improvements it is necessary and desirable that, said Church borrow the sum of Three Thousand Dollars plus closing costs of lean from the Leeds Branch of The First National Bank of Birmingham, Alabama, to be secured by a mortgage on the Church and parsonage real estate situated at Sterrett, Shelby County, Alabama, said real estate being described as follows, viz:

Begin at the intersection of the south line of the SE of SW of NE of Section 19, Township 18 South, Range 2 East, with the east line of the Pumpkin Swamp dirt road (as said road existed on or prior to October 2, 1961) and run thence east along the south line of said quarter quarter-quarter section a distance of 110 yards; thence run in a northerly or northeasterly direction parallel with the east line of said road 110 yards; thence run in a westerly direction parallel with the south line of said quarter-quarter-quarter section 110 yards to a point on the east line of said road; thence run in a southerly direction along the east line of said road 110 yards to the roint of beginning, and

WHEFEAS, notice of the time, place, and object of this special meeting or given
business was/more than ten days prior to this special meeting by posting such

notice in writing at the place of regular meeting of said Church on May 10, 1964, and by oral announcement to the congregation assembled for morning worship and regular meeting by the pastor on May 10, 1964, and again on May 17, 1964, the Sunday before this special meeting; and

WHEREAS, all rules of and discipline of this Church relating to the calling of this special meeting and the prior notice thereof and relating to the authorizing and approving of the said proposed mortgage loan contemplated, and the execution thereof, have now been complied with,

NOW, THEREFORE, HE IT FESOLVED, by the membersof the Church of God of Prophecy at Sterrett, Alabama, an ecclesiastical organization, in this special business meeting assembled, that said proposed mortgage loan be, and the same is hereby, arroved in all respects.

Be it further MESONNED that Jimmy Ray Howard, Marvin Fobertson, Bill
Howard, and James Harold Isbell, as Trustees of said The Church of Cod of
Prophecy at Sterrett, Alabama, and they are hereby, elected, arrointed,
and confirmed as the true and lawful Trustees of said Church, for said
Church and in its name, to further negotiate for said mortgage loan and to
execute and deliver any and all legal documents which may be necessary to
effect said proposed mortgage loan for said amount of Three Thousand Dollars
plus closing costs of loan
from said Leeds Branch of The First National Bank of Bimmingham, Alabama,
including a note and mortgage secured by the real estate which is more
particularly described above, giving and granting unto said Trustees full
power and authority to do, for and as the official act of said Church, any
and all acts necessary and proper to be done in and about the promises,

And said resolution having been read aloud in full by the Church Clerk it was moved by member Brother formed Horald Shell and seconded by member Brother Rell Houngs that all rules governing the membership which might, unless suspended, prevent the passing and adoption of said resolution at this special meeting, be, and the same are hereby suspended, for the purpose of permitting the said resolution to be finally passed and adopted at this special meeting.

WHETEUFOI, the moderator put the question on said motion for the suspension of the rules, and on the vote of the members tabulated by the moderator and the Clerk, the vote was as follows: Voting yea 1009; voting nay None

THEREJPON, the moderator declares said motion carried and the rules suspended.

Hember Brother fames Roy House then moved that said resolution be finally passed and adopted as introduced. Member Brother fames House Salve seconded the motion.

The question being put upon the final passage and adoption of said resolution, and on the vote of the members tabulated by the moderator and the Clerk, the vote was as follows: Voting yea/00%; voting nay None.

The moderator thereupon declared said motion carried and the resolution finally passed and adopted.

The object of said meeting is to adopt a resolution signifying the desire and intention of the members of said Church to borrow the sum of \$3,000.00 from the Leeds Branch of The First National Bank of Eirmingham, Alabama, to be secured by a mortgage on the Church and parsonage real estate situated in Sterrett, Alabama, and to authorize the trustees of said Church to execute the mortgage, note, and all necessary papers to effect said loan on behalf of said Church.

Jimmy Ray Roward, Church Clerk and Treasurer"

The BURNS, on, wo-wit, May 10, 1964, and again on May 17, 1964, the Sunday prior to this special meeting.

There being no further business to be conducted, the special business meeting was adjourned.
