Personally appeared before me, the undersigned authority, in and for said County and State, O. O. Fowler, who, first being duly sworn, deposes and says:

That my name is O.O. Fowler and I am the same O. O. Fowler who purchased on September 17, 1948, the E $\frac{1}{2}$ of NE $\frac{1}{4}$ of Section 4, Township 19 South, Range 1 West, Shelby County, Alabama, from George Huddleston, the deed to said land being recorded in the Probate Office of Shelby County, Alabama in Deed Book 136, page 185. I am 56 years of age and at the time that I purchased the foregoing land I went into the immediate possession of the same and was familiar with the property which adjoined me described as the E $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 4, Township 19 South, Range 1 West, Shelby County, Alabama. At that time the property was known to me as being the property of Mr. Paul O. Luck from Columbiana, Shelby County, Alabama. I later found out that he had a partner in the ownership of the land, namely, Mrs. Lena Brewer, the wife of R. Brewer. I knew of my own knowledge that Mr. Luck and Mrs. Brewere were in possession of the land and saw Mr. Luck and Mr. Brewer go on the land several times to look after it, as they came through my property on most of their trips. They sold the timber off of the land at least twice to my knowledge and it was cut and removed I believe by Mr. Lynn.

Later, Mrs. Brewer sold her interest to Harris M. Gordon of Columbiana, Alabama and I know that he has been on the land several times to look after it and I have discussed with him the probable purchase of the property by me.

I know that the possession by Lena Brewer and her husband, R. Brewer and Paul O. Luck and Harris M. Gordon has been actual, exclusive, open, notorious, hostile and continuous to all the world and further that their title has never been questioned by anyone to my knowledge.
