The SW 1/4 of the NW 1/4 in fee simple; and the NW 1/4 of the SW 1/4 and part of the NE 1/4 of the SW 1/4 more particularly described as follows: Begin at the Southwest corner of said NE 1/4 of SW 1/4; thence East along the South line of said 40 a distance of 35 yards; thence North parallel with the West boundary of said 40 for a distance of 140 yards; thence West 35 yards to the West line of said 40; thence South 140 yards to the point of beginning; all located in Section 21, Township 20, Range 1 West, in Shelby County, Alabama; except the mineral and mining rights and privileges reserved in the deed from Saginaw Lime and Lumber Company to T. L. Kendrick dated December 15, 1910;

But there is excepted from this conveyance the following parcels:

(A) A tract of land in the SW 1/4 of the NW 1/4 more particularly described as follows: Commence at the Northeast corner of said SW 1/4 of NW 1/4; thence West along the North line of said 40 a distance of 73 yards to the point of beginning; thence continue West along said line 140 yards; thence South 70 yards; thence East 140 yards; thence North 70 yards to the point of beginning;

(B) Begin at the Southeast corner of said SW 1/4 of NW 1/4 and run North along the East boundary of said SW 1/4 of NW 1/4 to the center of the Columbiana to Tafton public road; thence in a Southwesterly direction along the center of said road to the first branch or drain; thence in a Southerly direction along the center line of said branch or drain to the South line of the SW 1/4 of the NW 1/4; thence East to the point of beginning;

(C) Part of the NW 1/4 of the SW 1/4 more particularly described as follows: Begin at the Northeast corner of said NW 1/4 of SW 1/4; thence West along the North line of said NW 1/4 of SW 1/4 70 yards; thence South parallel with the East line of the NW 1/4 of SW 1/4 162 yards; thence East 70 yards to the East line of said NW 1/4 of SW 1/4; thence North 162 yards to the point of beginning;

(D) Part of the NW 1/4 of the SW 1/4 more particularly described as follows: Commence at the Northeast corner of said NW 1/4 of SW 1/4; thence South along the East line of said NW 1/4 of SW 1/4 170 yards to the point of beginning; thence continue South along said line 87 1/2 yards; thence West 140 yards; thence North 87 1/2 yards; thence East 140 yards to the point of beginning.


