Sylvester Ambrose had five children. His oldest child, a son, Will L. Ambrose, was by his first wife and was my Half-Uncle, according to my understanding. Said Will L. Ambrose was the only child born of the first marriage of said Sylvester Ambrose. Sylvester Ambrose and Cyrena Ambrose had only four children, which were all of the children ever born of Cyrona Ambrose, namely, Hattie A. Farrar, E. S. Ambrose, J. B. Ambrose, and Charlie Ambrose.

E. S. Ambrose, my Father, died over twenty years ago. My Mother, Dora L. Ambrose, was his widow. There were only nine children ever born of said or four years of age), Claude Edgar Ambrose, Ralph Ambrose, Lillian Fay Ambrose, Griffin, Franklin L. Ambrose, Ehnoy Ambrose, John Russell Ambrose, and Lavada Ambrose.

Hattie Ambrose Farrar had only three children, namely, James Farrar, Howard Ambrose Farrar, and Theo Ambrose Heyward. Said Hattie Farrar was a widow at the time of her death. Hattie Ambrose Farrar died prior to 1952.
