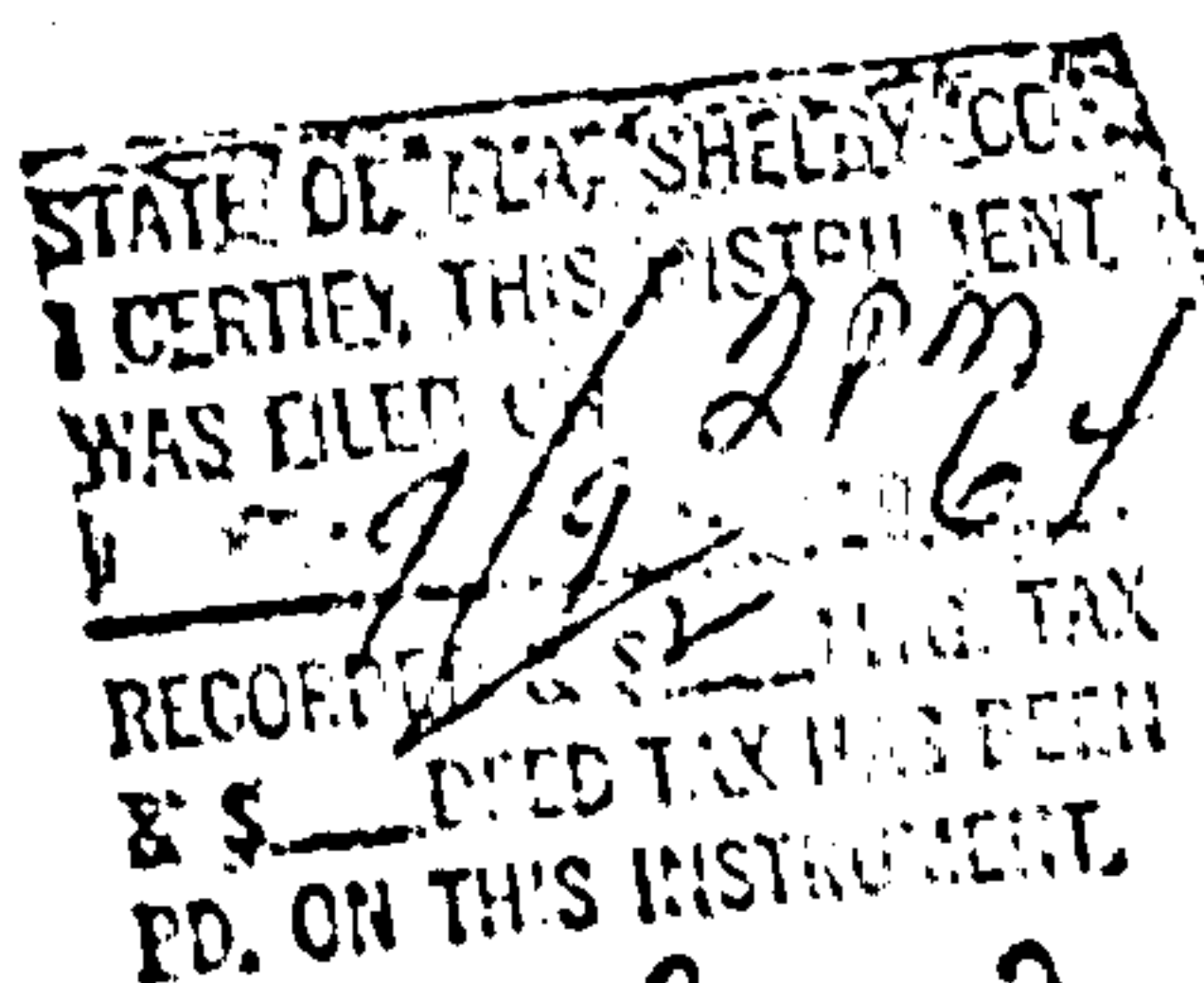
For value received, THE FEDERAL LAND BANK OF NEW ORLEANS, being the present owner of the indebtedness secured by that certain mortgage or deed of trust executed by Richard T. McGraw, recorded in Book 252, Page 500, of the land mortgage records of Shelby County, Alabama, does hereby release from said mortgage (deed of trust) the following:

A parcel of land situated in the SW1/4 of the NW1/4, Section 11, Twp. 19, range 2 east and more particularly described as follows: Begin at an iron stob at the NW corner of the F. P. Elliott Estate Land and the Calcis Road, which point is also the inter-section of the East R/W line of State Highway #25 with South line of said forty; thence run North-westerly along the said East R/W line of said Highway a distance of 305 feet to the point of beginning; thence run due east and parallel to the South line of said forty a distance of 318 feet to a point on the East line of said forty; thence run due North along the East line of said forty a distance of 65 feet to a point; thence run due West and parallel to the South line of said forty a distance of 326 feet to a point on the East R/W of said State Hwy #25; thence run Southeasterly along the R/W line of said Hwy a distance of 65 feet to point of beginning. ALSO: Begin at iron stob at NW cor. of the F. P. Elliott estate land and the Calcis Road, which point is also the intersection of East R/W line of State Hwy #25 with the South line of said forty; thence run north along the East R/W line of said Road a distance of 370 ft. to the point of beginning; thence run due east and parallel to the South line of said forty a distance of 326 ft. to a point on the East line thence run due North along east line of said forty a distance of 16 ft. to a point; thence run due west and parallel to the South line of said forty a distance of 328 feet to a point on the east R/W line of said Hwy #25; thence run South-easterly along R/W line of said State Hwy #25 a distance of 16 ft to the point of beginning.
