DECREE REMOVING DISABILITIES OF NON-AGE

This cause coming on to be heard upon the verified petition of Huey Lee Burnett, a minor, for the removal of the disabilities of non-age of said Huey Lee Burnett, this being the day set for hearing of said cause:

Now comes the petitioner, and the testimony of the witnesses having been taken by affidavit pursuant to the direction of the Court as noted by the Register, and the Court finding that the facts stated in the said petition are true; that the said Huey Lee Burnett resides in Shelby County, Alabama; that said Huey Lee Burnett is a minor over the age of eighteen years and will not reach the age of twenty-one years until February 4, 1967; that said Huey Lee Burnett owns real or personal property in Shelby County, Alabama; that said Huey Lee Burnett has no Father, Mother, or Guardian; and the Court being satisfied that it will be to the best interest of said minor to be relieved from the disabilities of non-age, and no objection being filed to the granting of said petition, it is, therefore,

CONSIDERED, ORDERED, ADJUDGED AND DECREED that the prayer of said petition be and hereby is granted; that it will be to the interest of the said minor, Huey Lee Burnett, to be relieved from the disabilities of non-age unconditionally and without restriction.

It is further CONSIDERED, ORDERED, ADJUDGED and DECREED that the said Huey Lee Burnett be and hereby is relieved from the disabilities of non-age unconditionally and without restriction and that he be and hereby is invested with the right to sue and be sued, contract, buy, sell and convey real estate and generally to do and perform all acts which he could lawfully do if twenty-one years of age; that a duly certified copy of this decree be filed for record in the Office of the Judge of Probate of Shelby County, Alabama; that the petitioner pay the costs in this behalf incurred.
