That in consideration of EIGHT HUNDRED AND NO/100 DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

D. W. Smith and wife, Lydia Smith

(herein referred to as grantors) do grant, bargain, sell and convey unto

James A. Lewis and wife, Virginia A. Lewis

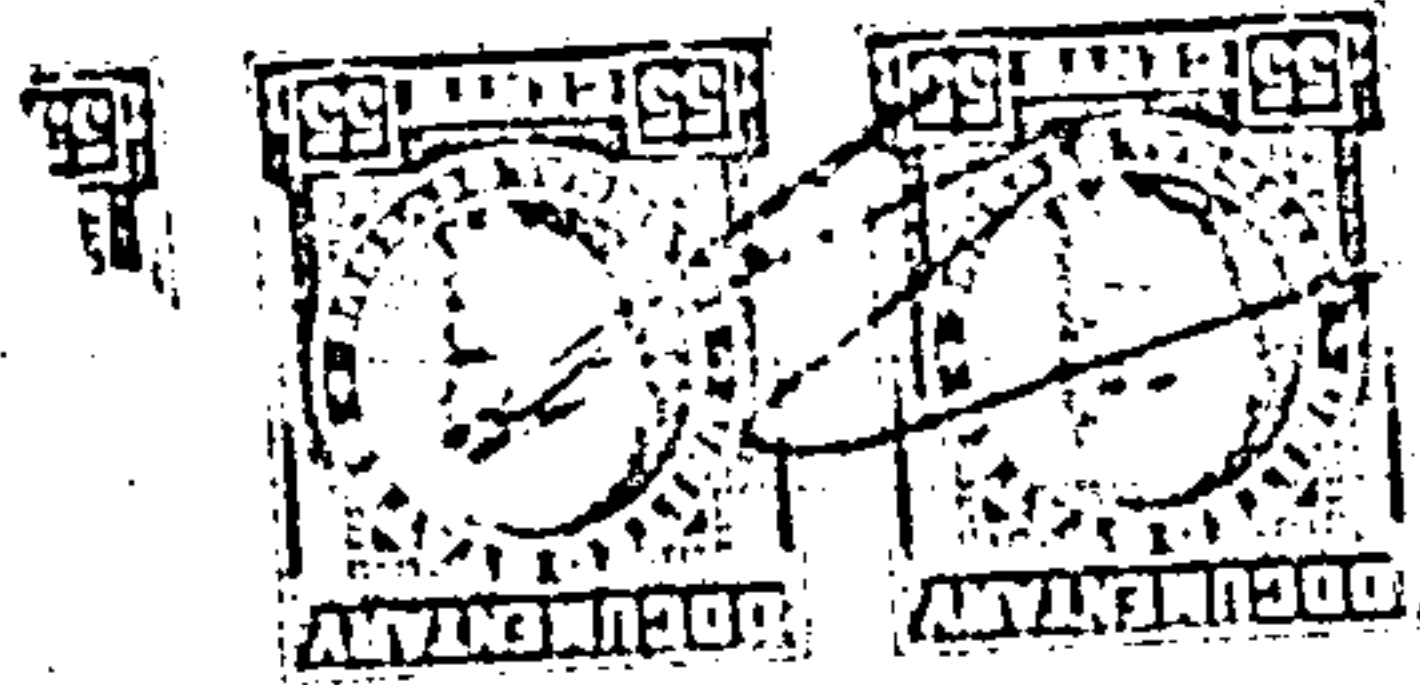
(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Above property shall not be used for business purposes and this covenant shall run with the land.

It is agreed that no building costing less than \$2500.00 to build shall be placed on the above described lot.

Sellers retain a Vendor's Lien for \$700.00 which is to be paid by purchasers to sellers at the rate of \$25.00 per month, commencing September 1, 1964; (interest payable 6% per annum from date), as shown by installment note.

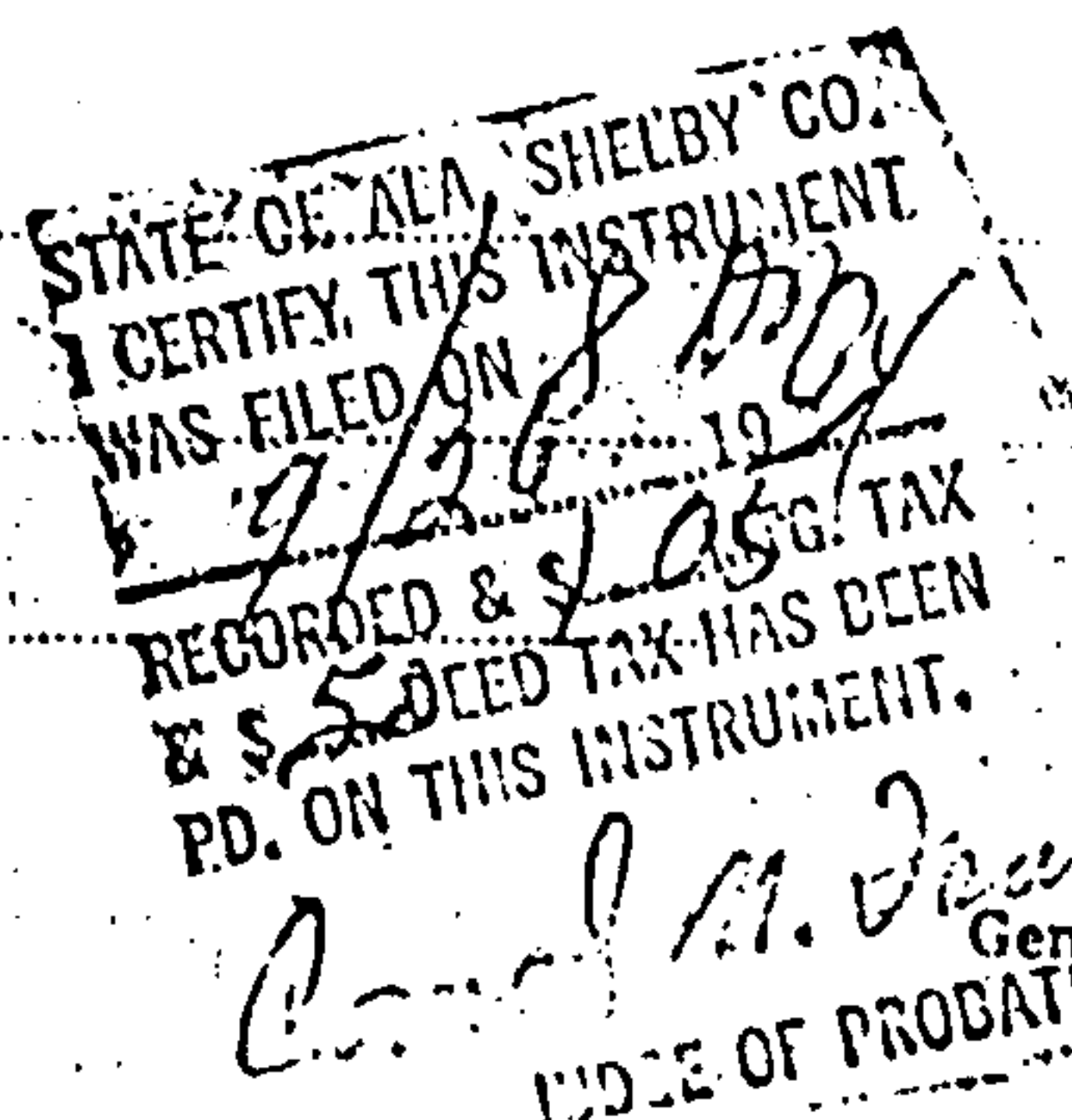
