Affiants further say that the affiant, J.M. Shirley, purchased the Northwest Quarter of the Southwest Quarter of Section 5, Township 20, Range 1 West, from N.C. Shirley, being one and the same person as "Nipper" C. Shirley, on December 31, 1901.

Affiants further say that of their own personal knowledge they know that for more than fifty years, last past, that Leo Kendrick and wife, Lorine Kendrick, and those through whom the said Leo Kendrick and wife, Lorine Kendrick hold title to said lands, namely, C.A. Shirley, Zoma Ann Shirley, and husband, J.M. Shirley, W.E. Harrison, Edward T. Cole, Edward M. 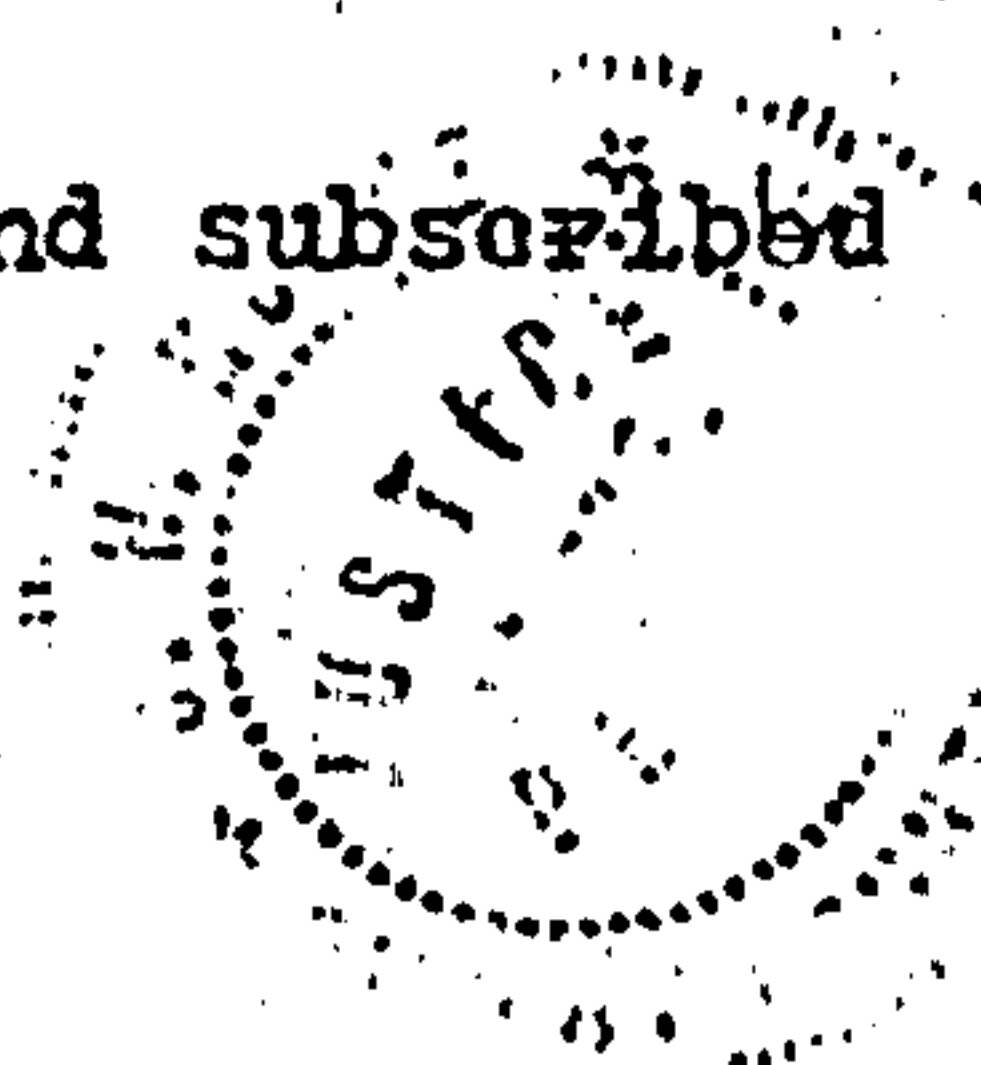

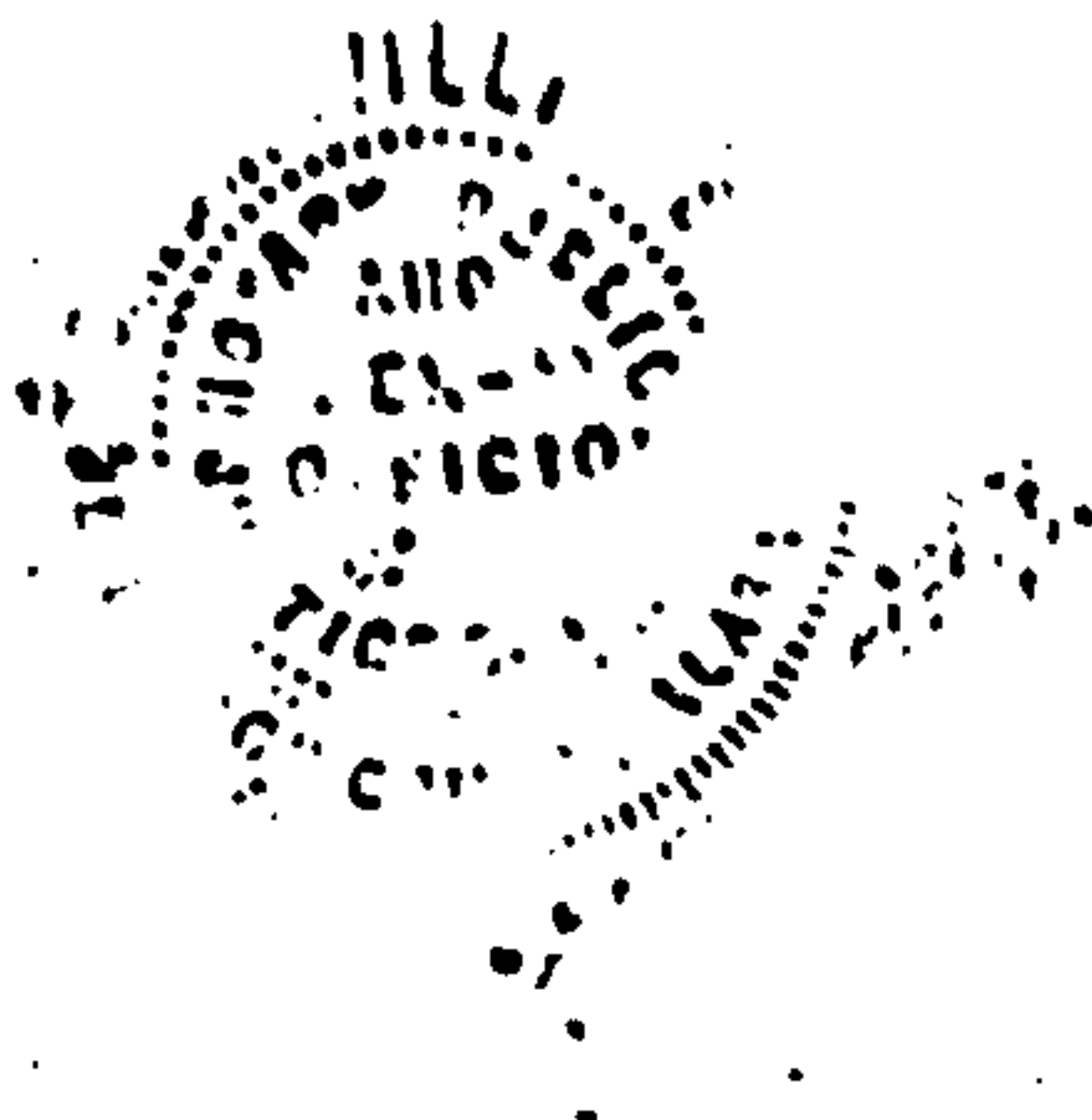
