My name is Hattie Thomas, I am past eighty-five years of age and reside at Montevallo, Alabama. I am the widow of Nazaree Thomas, who died in August, 1905.

Nazaree Thomas was never married to anyone but me, and I have never been married to anyone but Nazaree Thomas. Nazaree Thomas and I had two children, which were all of the children ever born to either of us.

One of our children, a daughter, Bessie Thomas, married Earnest Scott. Our said daughter died in 1936 without ever having had any children; her husband, said Earnest Scott has subsequently died.

Our other child, a son, Junius Thomas, died five or six years ago without ever having had any children. His widow, Tinnie Thomas subsequently married a man whose last name was "Ware", I believe, and has moved out of this State.

In June, 1905, before my husband's death, my husband and I bought and went into possession of the following described property:

Lot No. 14 according to Storrs and Troy Addition to Town of Montevallo, Alabama, as surveyed by N. B. Dare, as recorded in Map Book 3 on page 3 in Probate Office of Shelby County, Alabama.

Within two or three years after my husband's death, I had a house built on the above described property. I immediately moved into said house after it was built, and I have resided in said house on said property continuously, for over fifty-five years, until the present date. My husband and I received our deed to this property, which is recorded in Deed Book 36 at page 117, Office of the Judge of Probate, Shelby County, Alabama, at the time when we bought said property.

It has been pointed out to me that the petition which was filed by the Administrator of my husband's Estate in 1905 stated my name as "Ella Thomas", but this is in error, as my true name is Hattie Thomas. As stated above, Nazaree Thomas was never married to anyone except me.

I, and the heirs of Nazaree Thomas named above, until the time of their respective deaths, and I alone since the death of said Junius Thomas, have been in the open, continuous, notorious, undisturbed, peaceable, exclusive, hostile, actual adverse possession of all the above described property since 1905 until the present date.
