## EASEMENT

O1 min. east a distance of 1067.56 feet; thence run south 14 deg. 59 min. east a distance of 210.0 feet to a point on the north right of way line of Alabama Highway No. 70; thence turn an angle of 89 deg. 45 min. to the right and runsouth 74 deg. 46 min. west a distance of 1661½ feet to the point of beginning of the center line of said 5 foot easement, the same being 2½ feet east of the northeast corner of Janet D.
