Rowland lot; thence south 87 deg. 53 min. 30 sec. west along the said north boundary of said Rowland lot a distance of 9.0 feet to a point; thence south 2 deg. 06 min. 30 sec. East along the west boundary of the said Rowland lot a distance of 167.0 feet to the point of intersection with the centerline of East Sterrett Street, being the point of beginning of the right of way herein conveyed; thence north, 87 deg. 17 min. 30 sec. east along the centerline of the said East Sterrett Street, a distance of 18.9 feet to a point; thence south 2 deg. 31 min. 30 sec. East along the east boundary of the said SWH of SWH, a distance of 639.0 feet to a point on the north boundary of the J. D. Rowland lot; thence south 87 deg. 53 min. 30 sec. west along the said north boundary of the said Rowland lot a distance of 9.0 feet to a point; thence south 2 deg. 06 min. 30 sec. East along the west boundary of the said Rowland lot, a distance of 167.0. feet to the point of intersection with the centerline of East Sterrett Street; thence north 87 deg. 17 min. 30 sec. east along the centerline of the said East Sterrett Street, a distance of 18.9 feet to a point; thence south 2 deg. 31 min. 30 sec. Fast along the centerline of Goodwin Street, a distance of 405.0 feet to the point of beginning of the right of way herein conveyed; thence continue south 2 deg. 31 min. 30 sec. East along the centerline of the said Goodwin Street, a distance of 140.0 feet to the point of ending. Said right of way shall be 20.0 feet in width on the west side of the said Goodwin Street.
