KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED (\$100.00) DOLLARS, and other good consideration, to the undersigned JACK L. HALL and wife, BETTY PICKETT HALL, in hand paid by Exchange Security Bank, Birmingham, Alabama, and Mary Lee Garrett Brown, as trustees under trust agreement for the benefit of Pamela Sue Brown executed by Jadie A. Brown, Jr. on December 28, 1962, the receipt whereof is acknowledged, we the said Jack L. Hall and wife, Betty Pickett Hall, do grant, bargain, sell and convey unto the said Exchange Security Bank and Mary Lee Garrett Brown as Trustees under trust agreement for the benefit of Pamela Sue Brown executed by Jadie A. Brown, Jr. on December 28, 1962, an undivided one-third (1/3) interest in and to the following real property, together with all improvements, hereditaments and appurtenances, located in Shelby County, Alabama viz:

A lot in the Town of Montevallo, Alabama, in the Fractional NW¹/₄ of Section 3, Township 24 North, Range 12 East, more particularly described as follows: Commencing at the intersection of the South line of old Columbiana-Centre ville Road and East line of Shelby Street, and run in an Easterly direction along the South boundary of said road a distance of 470.1 feet to the NW corner of lot known as Section House lot; thence along North line of Section house lot North 75 deg. 57' East a distance of 208.89 feet to the NE corner of said Section House lot which is point of beginning of lot herein described; thence along East line of Section House lot South 16 deg. 38' East a distance of 161.04 feet to North right of way line of Southern Railroad; thence in a Northeasterly direction along North right of way line of said Southern Railroad a distance of 306 feet, more or less, to the SW corner of lot formerly known as Joe Deshazo lot (now belonging to Mack Dennis); thence in a Northwesterly direction along West line of Dennis lot a distance of 60 feet, more or less, to South line of old Columbiana-Centre ville Road; thence in a Westerly direction along the South line of said old road a distance of 297 feet, more or less, to point of beginning.
