This cause coming on to be heard is submitted for final decree upon the pleadings and proof as noted by the Register; and upon consideration thereof the Court is of opinion that the complainant is entitled to the relief prayed for in his bill of complaint. It is, therefore, ordered, adjudged and decreed by the Court:

1. That the complainant, Hobert Lee, is the owner of the real estate described in the original bill in this cause and which real estate is situated in the County of Shelby, State of Alabama; and more particularly described as follows:

All that part of the NE $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 31, Township 20 South, Range 2 East that lies south and west of Wilsonville-Harpersville (Highway # 25) paved highway, containing 7 acres, more or less, Except that part sold B. E. & Nellie Cunningham, as shown by deed recorded in Deed Book 204 page 93 in the Probate Office of Shelby County, Alabama, and also except easement sold to Southern Electric Generating Company as shown by deed recorded in Deed Book 203 page 103 in said Probate Office; being situated in Shelby County, Alabama.

2. That the following named persons, if living, or if deceased, their heirs or devisees, namely: Sammie Crutchfield Hargrove, Maggie Mae Jenkins, Maggie Crutchfield Umphrey, Willie Crutchfield Gordon, Pinkie Crutchfield Bennett, Harvey Crutchfield, Nona Crutchfield Barton (also known as Nora Crutchfield Barton; Bamma Crutchfield, Mae Crutchfield, Oscie Crutchfield, John Shugart and Joseph Meyer, and respondents Charles J. Christian and Clarice Christian Harris, all being respondents in this cause, have no right, title or interest in or encumbrance upon said lands above described or any part thereof,

3. That the Register, within thirty days from this date, file a certified transcript of this decree for record in the Probate Court of Shelby County, Alabama, the County in which said land lies; and that the Probate Judge record and index said decree as required by Code 1940, Title 7, Section 1113 as Recomplied.

4. That the complainant pay the costs of this suit to be taxed by the Register, for which let execution issue.
