RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS. That we, the undersigned, _____

Parcel I. Beginning at a point on the centerline of Project CP2-76 at Station 0+33, the northwest property line, said point being also a point on the southeast right of way line of State Highway 25; thence along the centerline of said project S 47° 27'E a distance of 681' to the point of beginning of the curvature of the centerline; thence southeasterly along the centerline of said project along a 1° curve to the left a distance of 785' to the point of ending of the curvature of the centerline; tehnce along the said centerline S 55° 18' E a distance of 88.6' to the point of beginning of the curvature of the centerline; thence southeasterly along the said centerline along a 10° curve to the left a distance of 165.4' to the point of ending at Station 17+30, the southeast property line. Said parcel of land being 40' wide on each side of centerline of said project from Station 0+33 to Station 5+00; thence 40' wide on the right (southwest) side of centerline to Station 17+30. Also to include a flare on the righg beginning at a point 40' right and at right angles to Station 1+00; thence N 47° 27' W along the 40' right of way line a distance of 70', more or less, to a point on the right of way line of State Highway 25; thence southwesterly along the Highway 25 right of way a distance of 65', more or less, to a point; thence southeasterly a distance of 100' to the point of beginning. Said parcel of land is lying in the NE 1/4 of SE 1/4 and SE 1/4 of SE 1/4, Sec. 14, T 22 S, R 2 W and SW 1/4 of SW 1/4, Sec. 13, T 22 S, R 2 W and contains 2.68 acres, more or less, including that part now occupied by the present road.

Parcel II. Beginning at a point on the centerline of Spur A of said project at Station 0+33, the northeast property line; thence along the centerline of said Spur S 49°15'W a distance of 743.9' to the point of beginning of the curvature of the centerline; thence southwesterly along the centerline of said 'spur along a 2° curve to the left a distance of 585' to the point of ending of the curvature of the centerline; thence along said centurline S 37° 33' W a distance of 697.1' to the point of beginning of the curvature of the centerline; thence southwesterly along the said centerline along a 3° curve to the right a distance of 442.2' to the point of ending of the curvature of the centerline; thence along the centerline of said Spur S 50° 49' W a distance of 102.8' to the point of ending at Station 26+04, the south property line. Said parcel of land being 40' wide on the right (north) side of centerline of said spur from Station 0+33 to Station 2+38; thence 40' wide on each side of centerline of said project to Station 18+14, except from Station 11+00 to Station 13+61.9 which shall be 30' wide on the left; thence from Station 18+14 to Station 26+04 which shall be 40' wide on the left side of center line. Said parcel of land is lying in the SW 1/4 of SW 1/4 N Sec. 13, T 22 S, R 2 W and the SE 1/4 of SE 1/4, Sec. 14, T 22 S, R 2 W and the NE 1/4 of NE 1/4 and NW 1/4 of NE 1/4, Sec. 23, T 22 S, R 2 W and contains 3.81 acres, more or less, including that part now occupied by the present road.
