

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

STATE OF ALABAMA

Shelby County

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be _____ see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. CP2-76 as recorded in the office of the Judge of Probate of Shelby County.

Beginning at a point on the centerline of Spur B of Project CP2-76 at Station 25+00 the north property line; thence along the centerline of said spur southeasterly along a 6° curve to the right a distance of 418' to the point of ending of the curvature of the centerline; thence along centerline of said Spur S 17° 08' E a distance of 98.4' to the point of beginning of the curvature of the centerline; thence southwesterly along the centerline of said spur along a 16° curve to the right a distance of 325' to the point of ending of the curvature of the centerline; thence along the centerline of said spur S 34° 52' W a distance of 85.7' to the point of beginning of the curvature of the centerline; thence along the centerline of said spur southwesterly along a 20° curve to the left a distance of 215' to the point of ending of the curvature of the centerline; thence S 8° 08' E along the centerline of said spur a distance 277.9' to the point of ending at Station 39+20, the south property line.

Said parcel of land being 40' wide on each side of centerline of said project and is lying in the NE 1/4 of NW 1/4, Sec. 6, T 24 N, R 14 E and contains . 2.61 acres, more or less, including that part now occupied by the present road.

All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
