KNOW ALL MEN BY THESE PRESENTS, That HELENA CUMBERLAND  
PRESBYTERIAN CHURCH, for and in consideration of the sum of ONE  
AND No/100 Dollar (\$ 1.00 ) to it in hand paid by Alabama  
Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to  
said Alabama Power Company, its successors and assigns, the right to construct, operate  
and maintain its lines of poles and towers and appliances necessary in connection there-  
with, as located by the final location survey heretofore made by said Company, for the  
transmission of electric power, with the right to string thereon from time to time,  
electric power and telephone wires and the right to permit other corporations and persons  
to attach wires to said poles and towers upon, under, over, and across the following  
described land situated in SHELBY County, Alabama: FOURTEEN LOTS BEING  
THE WHOLE OF TUSCALOOSA ROAD BLOCK IN THE TOWN OF HELENA,  
BEGINNING AT A POINT WHERE THE OLD TUSCALOOSA ROAD (NOW ABANDONED)  
INTERSECTS WITH MAIN STREET (ROCK CORNER SET IN MIDDLE OF SAID ROAD); THENCE  
RUN N 34° 10' E 691 FT ALONG THE SE SIDE OF MAIN STREET TO THE NW CORNER  
OF SAID BLOCK; THENCE RUN N 58° 18' E 198 FT TO THE NE CORNER; THENCE  
S 8° 20' W 158 FT TO A POINT; THENCE DUE WEST 123 FT TO A POINT;  
THENCE DUE SOUTH 329.6 FT TO A POINT IN THE OLD TUSCALOOSA ROAD;  
THENCE ALONG THE OLD TUSCALOOSA ROAD S 77° 15' W TO THE POINT OF BEGINNING  
LYING IN THE SW 1/4 OF THE SW 1/4 OF SECTION 15 AND IN THE NW 1/4 OF  
THE NW 1/4 OF SECTION 22, TOWNSHIP 20 S, RANGE 3 W, EXCEPTING  
AND RESERVING A STRIP 15 FT WIDE ALONG THE EXTREME NORTH  
BOUNDARY OF SAID BLOCK, ABOUT 129 FT LONG.

Together with all the rights and privileges necessary or convenient for the full  
enjoyment or use thereof, including the right of ingress and egress to and from said  
lines, and also the right to cut and keep clear all trees and to keep clear other  
obstructions that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns  
forever.
