Also the Ez of NE and NE of SE and Ez of NW of SE of Section 36, Township 19 South, Range 2 East;



Creswell, her children rented the land to tenants and Major and Bob White rented the land for some ten years and after that affiant's brother, Aldrich Datcher rented the land for approximately 8 years and they each cultivated corn and cotton on it and since that time, afflant has been renting it and farming it each and every year until the present time.

There has been called to affiant's attention a Tax Sale in the name Mrs. Jane Gallup to the State of Alabama covering E2 of NE2 of said Section 36, which is recorded in Tax Sale Record 9 page 341 in said Probate Office. Affiant says he knows of his own knowledge Mrs. Jane Gallup did not own the above land nor any part of it in 1926 and she has never owned any part of it since.
