for and in consideration of the sum of ONE AND NO/100 Dollars (\$ 1<sup>00</sup> ), to US in hand paid by Alabama Power Company, a corporation, the receipt of which is hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to implant, install and maintain anchor S. of wood or other material at 2 point S. on the property hereinafter described, and to construct, extend and maintain guy wires from said anchor S. to structures now erected or hereafter to be erected on said land. Said anchor S. and guy wires to be located on and across lands of the undersigned in the County of SHELBY, State of Alabama:

The lands on which said anchor S. and guy wires are to be implanted or installed are described as follows:

*A portion of land situated in the East 1/2 of the Northwest 1/4 Section 3 Township 24 Range 12 East more fully described as follows; begin at the intersection of the right of way of Southern Railroad and Shilton Baptist Church; thence run Northward along said right of way a distance of 456 ft. thence run Northwest a distance of 321 ft, thence run West a distance of 154 ft to a point in the center of Nelson Springs, thence run Southwest, along Shoal Creek a distance of 450 ft to a point, thence run South a distance of 160 ft to the point of beginning.*

TO HAVE AND TO HOLD the same to the said Alabama Power Company, its successors and assigns, forever.

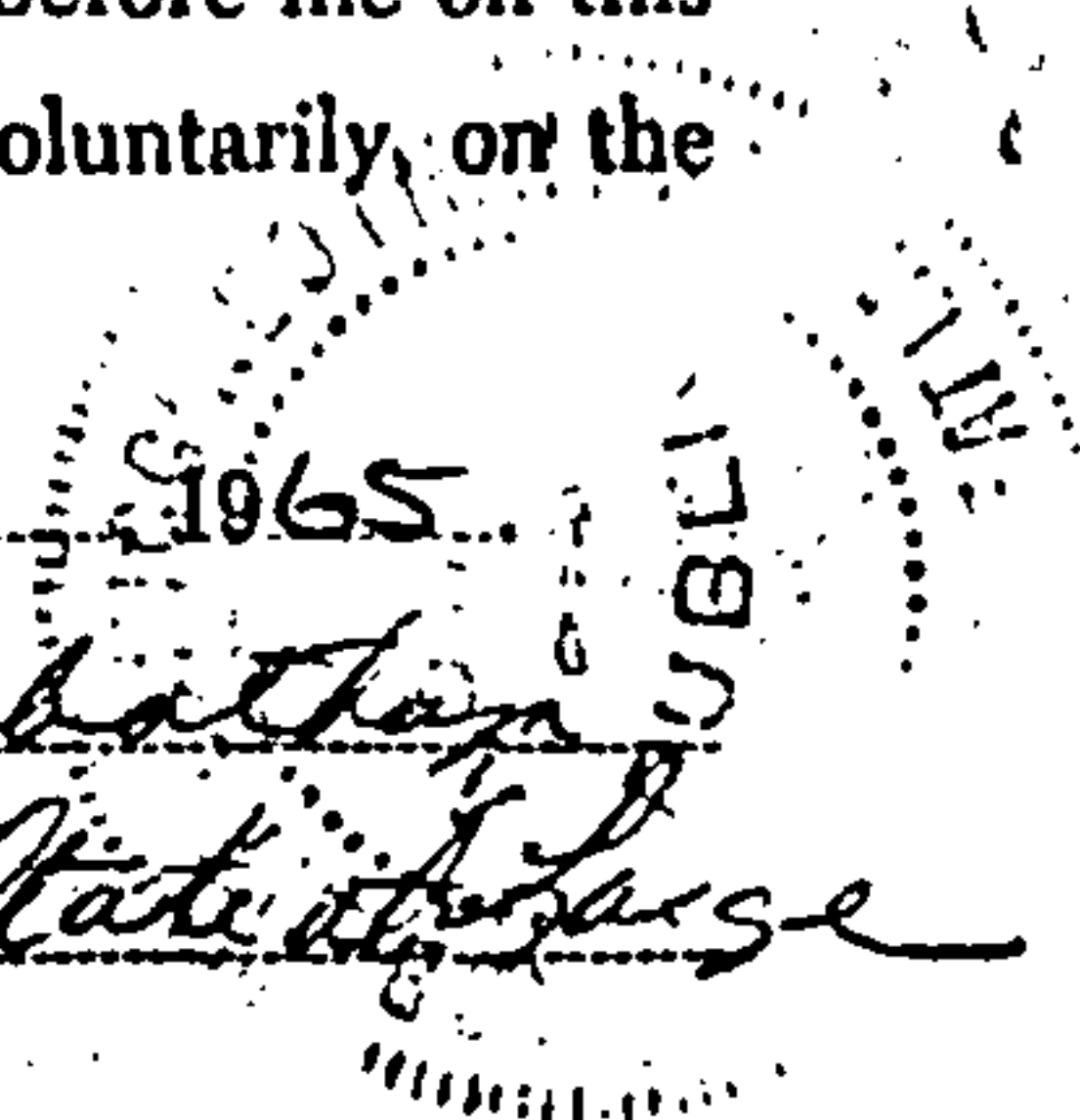

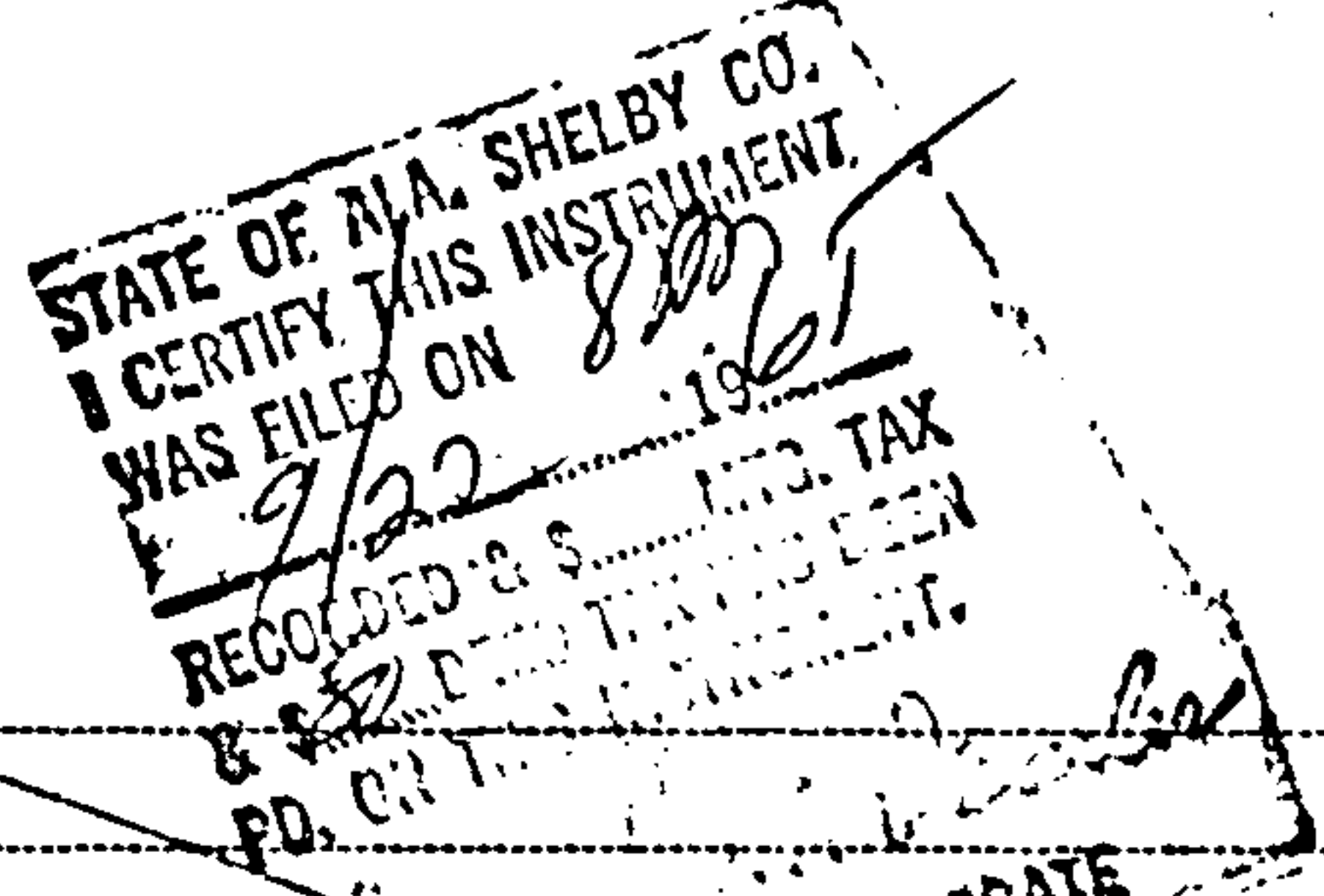
