Watson and wife Beulah Watson, receipt of which is hereby acknowledged, the Anniston Production Credit Association, a corporation does hereby release from that certain mortgage executed by J. W. Watson and wife Beulah Watson to Anniston Production Credit Association, a corporation, dated March 5, 1965 and recorded in Volume 292, page 573 of the Mortgage records in the Office of Judge of Probate, Shelby County, Alabama, the following described property:

Commence at the Southwest corner of the SE $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 15, Township 18 South, Range 1 East, thence run North along the West boundary line of said quarter-quarter section a distance of 600 feet to the point of beginning; thence turn an angle of 90 deg. to the right and run East parallel to the South boundary line of said quarter-quarter section a distance of 630 feet; thence turn an angle to the left of 90 deg. and run North parallel to the West boundary line of said quarter-quarter section a distance of 420 feet; thence turn an angle to the left of 90 deg. and run West parallel to the South boundary line of said quarter-quarter section a distance of 630 feet to the West boundary line of said quarter-quarter section; thence run South along said boundary line a distance of 420 feet to the point of beginning. Situated in Shelby County, Alabama.
