mortgage having been executed by Jimmie Martin and wife, Gladys Martin

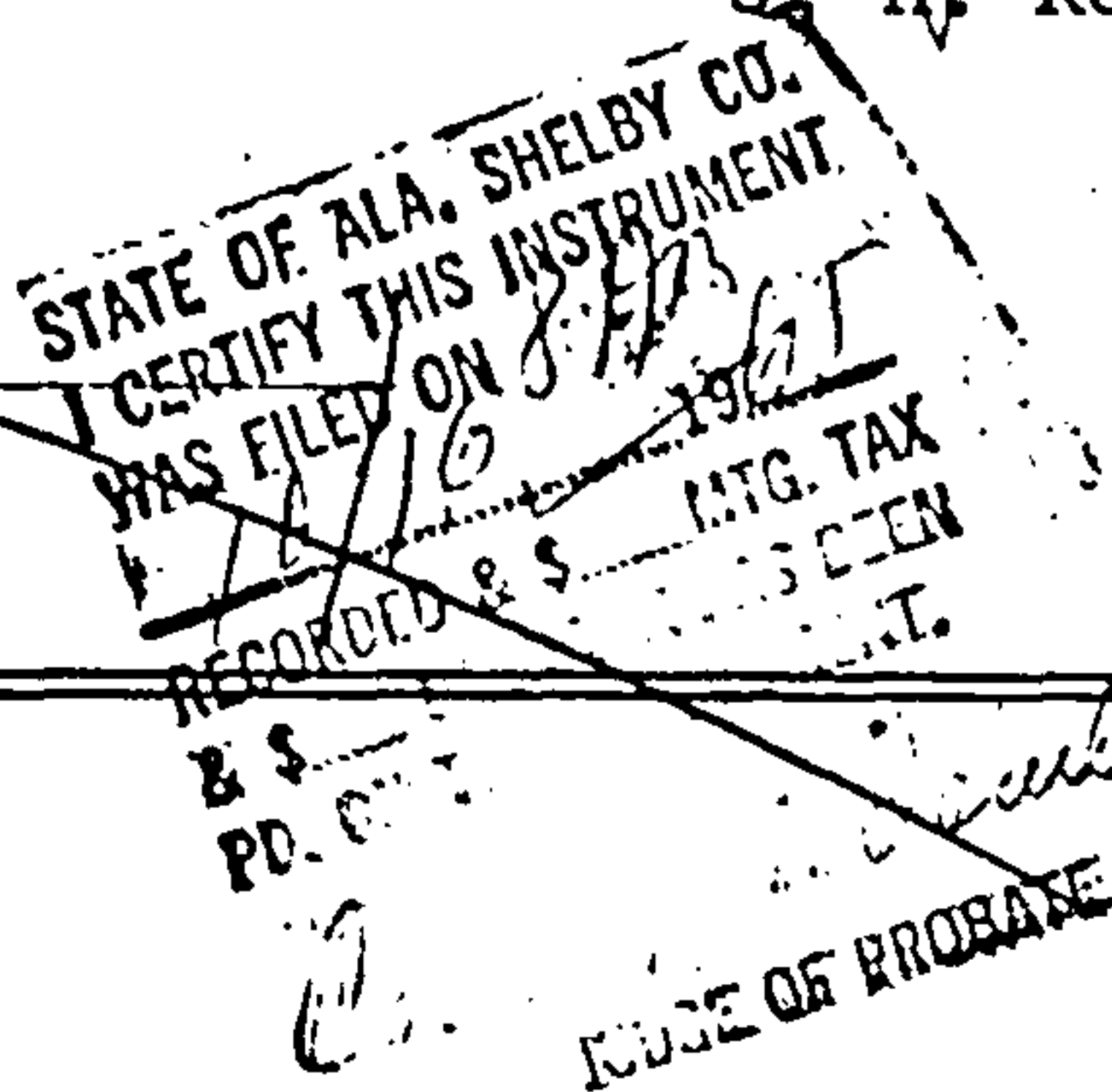
on the property in said mortgage described for the purpose of securing the payment of an indebtedness to the said
