

## DEED TO REAL ESTATE AND ALL APPURTENANCES

THIS INDENTURE, made and entered into, this 30th day of December 1964

of Education, party of the second part, witnesseth that whereas it has been decided by the State of Ala-

part received for school purposes as set out in the deed conveying the same to the State; and whereas
the Board of Education of Shelby County has requested the transfer of the
Vincent school property and has certified to A. R. Meadows, as
Superintendent of Education of the State of Alabama, that it is for the benefit of the public schools in
said county that said lands be so transferred.
AND WHEREAS, the State Superintendent of Education, with the approval of the Governor, has

Meadows, as Superintendent of Education of the State of Alabama, in pursuance of the authority conferred upon us by law, do hereby for the State and in its name grant, bargain, quitclaim and convey and by these presents have granted, bargained, quitclaimed and conveyed unto the party of the second part all of the right, title, and interest of the State of Alabama in and to the following described property, to-wit: VINCENT SCHOOL
