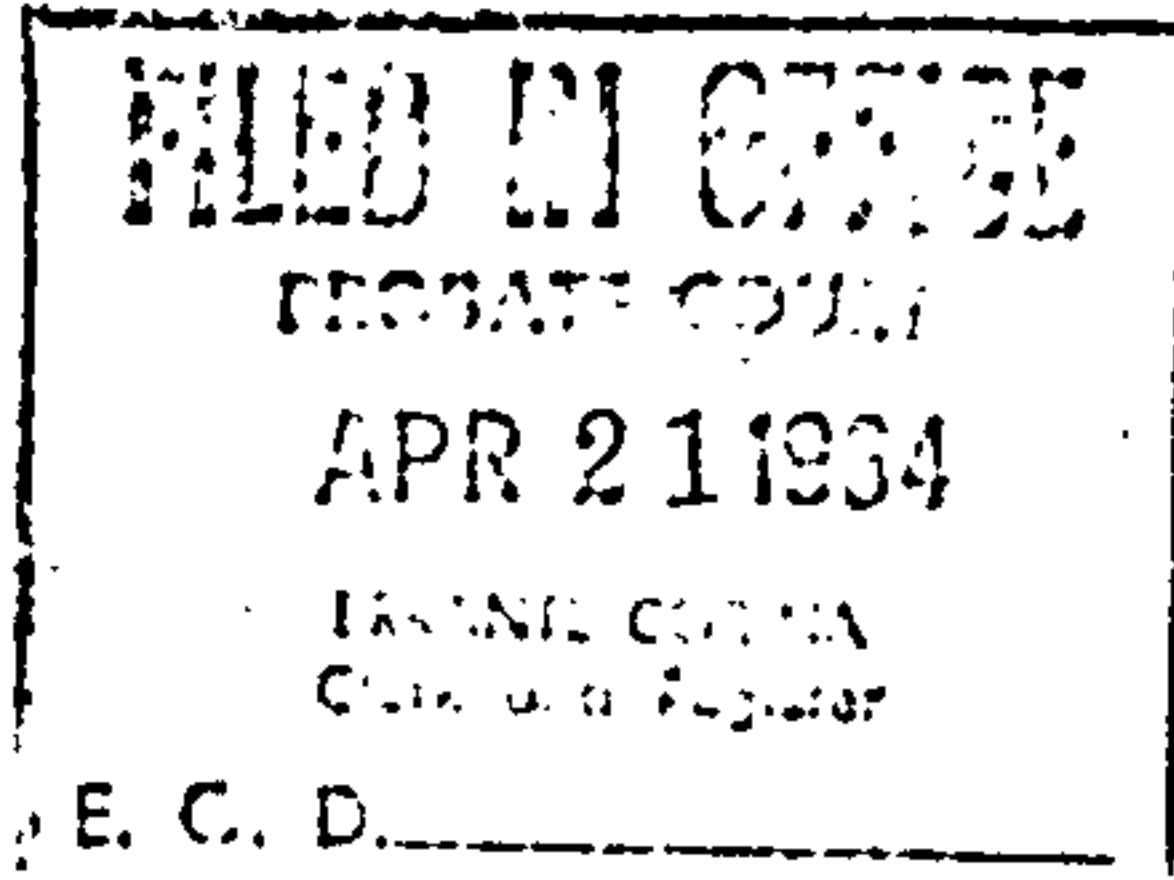

LAST WILL AND TESTAMENT OF CLARA BOWEN OZLEY

KNOW ALL MEN BY THESE PRESENTS, that I, Clara Bowen Ozley, of the City of Birmingham, Jefferson County, Alabama, being over the age of twenty-one years, and being of sound mind and disposing memory, and considering the uncertainty of this life, do hereby make, ordain, publish, and declare this to be my last Will and Testament, hereby revoking any and all other wills made by me prior to the date of this Will.

As to my worldly Estate and all the real, personal, or mixed property of which I shall die seized and possessed, and to which I shall be entitled at the time of my death, I devise, bequeath and dispose thereof in the manner following, to-wit:

FIRST: My Will is that all of my just debts and funeral expenses shall, by my Executrix hereinafter named, be paid out of my Estate as soon after my decease as may be convenient.

SECOND: I give, devise, and bequeath to my granddaughter, Ruth Tower, my personal wrist watch and diamond solitaire ring, with the provisor that the wrist watch and diamond ring shall remain in the possession of Ruth Tower's mother, Clara Elizabeth Ozley Tower, until Ruth Tower becomes eighteen years of age, at which time I direct that same be delivered to her.

THIRD: I give, devise, and bequeath to my grandson, James A. Tower, the wrist watch left to me by my late husband, George R. Ozley, with the provisor that the wrist watch shall remain in the possession of James A. Tower's mother, Clara Elizabeth Ozley Tower, until James A. Tower becomes eighteen years of age, at which time I direct that same be delivered to him.

FOURTH: I give, devise and bequeath my wedding band to my nephew, Reese Elledge.

FIFTH: I give, devise and bequeath to my beloved daughter, Clara Elizabeth Ozley Tower, all the rest and residue of my Estate, including real, personal, and mixed property of which I shall die seized and possessed or to which I shall be entitled at the time of my decease wherever situated.

SIXTH: I nominate and appoint my beloved daughter, Clara Elizabeth Ozley Tower, as Executrix of this, my Last Will and Testament, and I hereby declare that she shall not be required to give any bond for the performance of her duties arising hereunder, nor shall such Executrix be required to make any report or file any inventory or make any appraisal or final settlement to any court of the property or effects coming into her hands or in the performance of her duties arising hereunder as such Executrix.

IN TESTIMONY WHEREOF, I, the said Clara Bowen Ozley, have to this, my last Will and Testament, subscribed my name and affixed my seal on this the 10 day of April, 1957.
