That Paragraph 216 Section 7 provides as follows:

"To incorporate, where civil law permits and when authorized by the District Assembly. After incorporation, as above provided, the district advisory board shall have power, on its own resolution, to purchase, own, sell, exchange, mortgage, deed in trust, hypothecate, lease and convey any property, real and personal as may be necessary or convenient for the purpose of the corporation."
