That in consideration of TWO THOUSAND, SIX HUNDRED, SIXTY-ONE AND 08/100 (\$2,061.08) DOLLARS

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

Otwe Dorough and wife, Effie Dorough

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

Adron W. Dorough and Walton N. Dorough

(herein referred to as grantee, whether one or more), our undivided interest in, and to the following described real estate, situated in

Shelby

County, Alabama, to-wit:

The SW₄ of NE₄; the E₂ of SE₄ of NW₄; the E₂ of E₂ of SW₄; the N₂ of SE₄; and all of the SW₄ of SE₄ except the following land in the SE corner thereof, described as follows: Begin at the SE corner of said SW₄ of SE₄ for point of beginning; run thence West 220 yards; thence North 140 yards; thence East 90 yards; thence in a Northwesterly direction 173 1/3 yards; thence South 273 1/3 yards to point of beginning. All of the above described land being in Section 23, Township 20, Range 1 East.

Also, the following described lands: E₂ of NE₄ of NW₄; the NE₄ of the SE₄ of the NW₄; the W₂ of the NW₄ of the NE₄; the NW diagonal half of the NW₄ of the SW₄ of NE₄, all in Section 20, Township 20, Range 1 East, together with all the improvements thereon or thereunto pertaining; all the above described land being situated in Shelby County, Alabama.

This deed is given for the sole purpose of correcting that certain deed executed on March 30, 1964 from grantors herein to grantees herein upon which the acknowledging Notary Public failed to affix her official seal.

TO HAVE AND TO HOLD to the said grantee, his, her or their heirs and assigns forever.

And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators, covenant with said grantee, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrance, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will, and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantee, his, her or their heirs and assigns forever, against the lawful claims of all persons.
