hereby remises, releases, quit claims, grants, sells, and conveys to

Paul E. George and wife, Louise J. George

(hereinafter called Grantee), all our right, title, interest and claim in or to the fol-

lowing described real estate, situated in SHELBY County, Alabama, to-wit:

Lot 2 in Deed Book 138 at pages 555-556, in the office of the Judge of Probate of Shelby County, Alabama, which said Lot 2 being further described as follows: Begin at the north-east corner of Section 1, Township 21, Range 5 West and run thence west along the north boundary of said Section 275 yards to the point of beginning of the land herein described; thence continue west 275 yards; thence south 440 yards; thence east 275 yards; thence north 440 yds to point of beginning.

Also Lot 3 in Deed Book 138 at pages 555-556, in the office of the Judge of Probate of Shelby County, Alabama, which said Lot 3 being further described as follows: Begin at the south-east corner of the NE 1/4 of the NE 1/4 of Section 1, Township 21, Range 5 West and run north 1320 feet; thence west 330 feet; thence north 1320 feet to the north section line; thence west along said north line 247.5 feet; thence south 2640 feet; thence east 577.5 feet to point of beginning.
