ASSIGNMENT OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That United Plywoods Corporation, a corporation, for value received to it in hand paid by H. R. McBride does hereby grant, bargain, sell and convey and assign unto the said H. R. McBride all its right, title and interest in and to certain mortgages executed to it by Lucille Thompson, a widow and/or Billy Thompson, on the 27th day of August, 1959, and recorded in Volume 267, page 189 and volume 264, page 84 of the records of the Probate Court of Shelby County, Alabama, together with the debt secured thereby and all right, title and interest in and to the property therein described, to-wit:

Beginning on the North side of margin of the Montevallo and Wilton dirt road (sometimes called the Montevallo & Centreville Highway) at the Southeast corner of what was formerly known as the Mrs. Theo Kuffner lot, and which is now known as the Wilson Carter lot, and running thence along the North side or margin of said Montevallo & Wilton dirt road in a Northeasterly direction 210 ft; thence in a northwestern direction and parallel with the east boundary of said Wilson Carter lot 244 feet to a ditch, thence in a southwestern direction along the east margin of said ditch and parallel with the east boundary line of what was formerly known as the Cherry lot 222 ft., more or less, to the northeast corner of the said Wilson Carter lot, thence in a southeast direction along the East boundary line of said Wilson Carter lot 173 ft. to a point of beginning, and being a part of the west half of the northwest quarter of section 9, township 24 Range 12 East, situated in Shelby County, and in the town of Wilton, Alabama, and containing one acre, more or less.

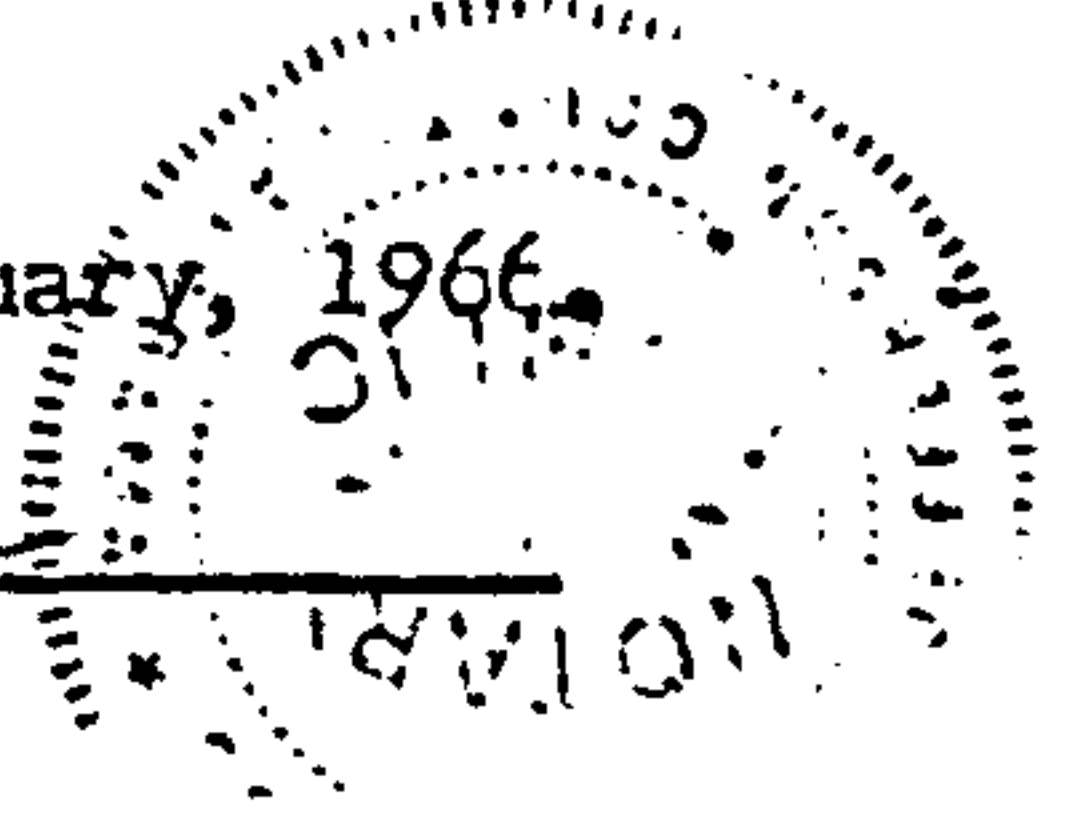
