This cause coming on to be heard on the pleading and proof as noted by the Register, and the Court having orally heard the testimony, and the same being considered and understood by the Court, the Court is of the opinion that the complainant is entitled to the relief prayed for in the bill of complaint, as last amended. It is, therefore,

CONSIDERED, ORDERED, ADJUDGED and DECREED by the Court that the complainant is entitled to the relief prayed for in his bill of complaint.

It is further, OCNSIDERED, ORDERED, ADJUDGED and DECREED By the Court as follows:

I. That the deed executed by the complainant to the respondents dated January 26, 1954, which said deed is recorded in the Probate Office of Shelhy County, Alabama in Deed Book 165, page 176, be and the same is hereby annulled and held for naught and the interest conveyed respondents Dick Isenhover and Jeanne Alice Isenhover is divested from said respondents and invested in the complainant, Ed Finch; the land conveyed in said deed mentioned above being described as follows:

Part of $E_{\frac{1}{2}}$ of $SW_{\frac{1}{2}}$ and of $SW_{\frac{1}{2}}$ of $SE_{\frac{1}{2}}$ of Sec. 22, Tp 19, Range 2 West, known as the J. E. Strickland place, and more particularly described as follows: Beginning at a point in the middle of Eshop Creek or Valley Creek near the SE corner of SE2 of SW2 of Section 22, Township 19, Range 2 West between an iron stake on the West side of a white oak tree on the East side of said Creek; thence running in a straight line a little west of North about 62 yards to an iron stake on the West side of the Montevallo road where a sweet gum tree is now standing on the West side of said road also where a lane intersects said road; thence in a straight line a little North of West about 12.8 chains to a stake on the West boundary line of SE of SW, said stake situated 10.15 chains North of SW corner of SE2 of SW2 of said Section; thence North along West boundary line of E of SW of said Section, about 690 yards to a stake at the NW corner of NEZ of SWA of said Section; thence in a SE direction about 150 yards to a cross fence between land of G.
