John M. Frew, Jr. and wife, Barbara G. Frew; Robert E. Okin and wife, Zackie H. Okin

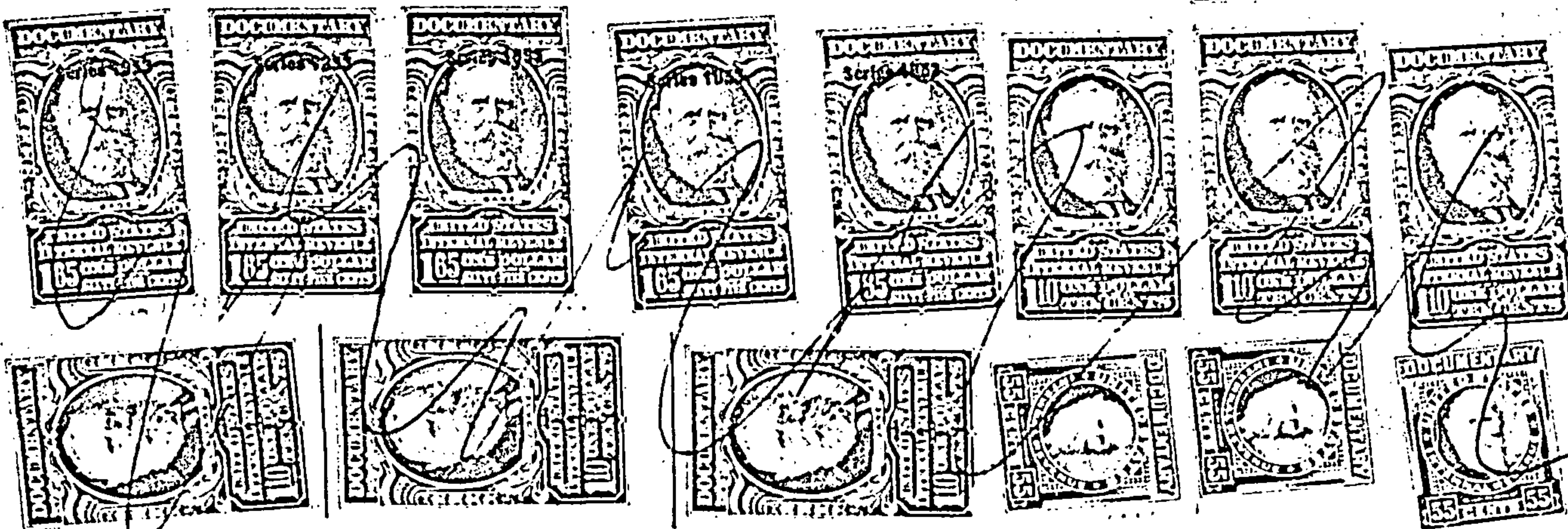
(herein referred to as grantee, whether one or more), the following described real estate, situated in

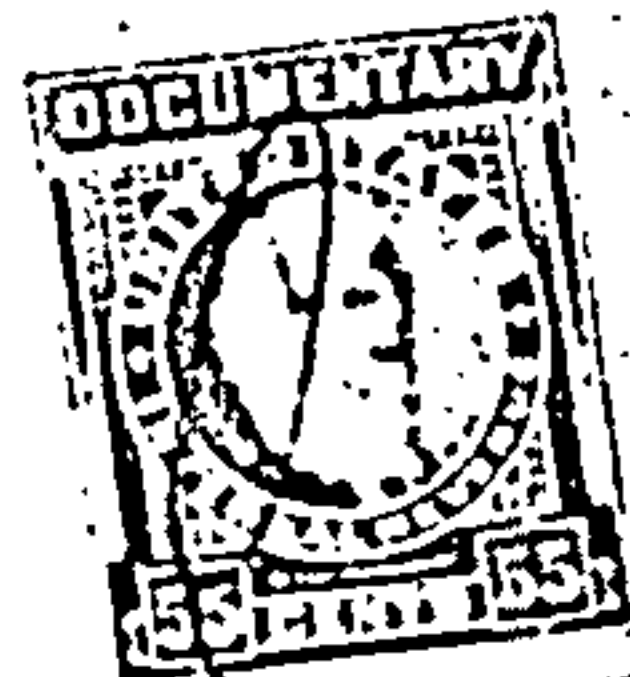


TO HAVE AND TO HOLD to the said grantee, his, her or their heirs and assigns forever.

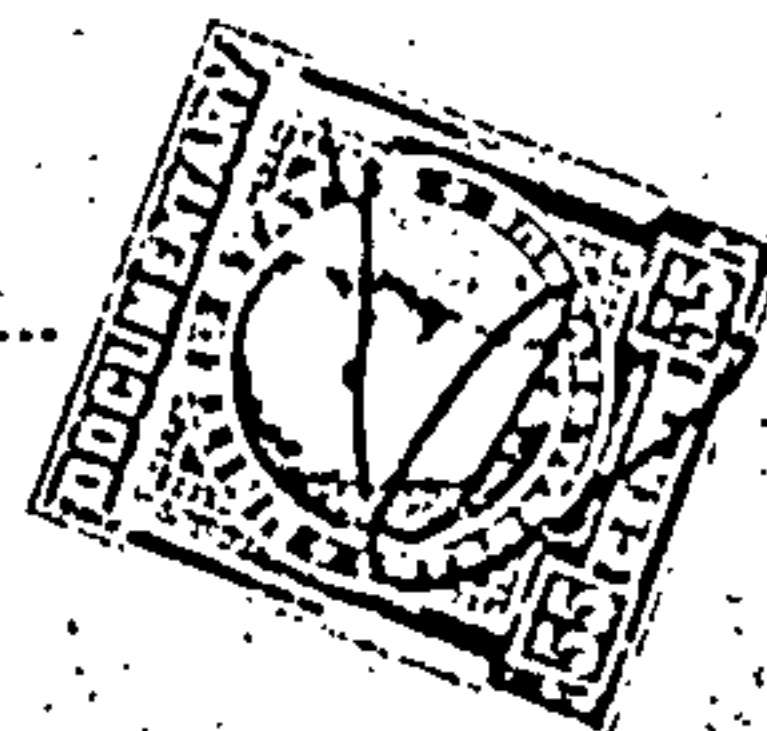
