PETITION AND WRITTEN DECLARATION OF VACATION OF A PORTION OF BUCK CREEK COTTON MILL COMPANY Map prepared by H. A. Turner, Engineer.

WHEREAS, Siluria Mills, Inc. is the owner of all the land abutting that portion of the hereinafter described streets and alleys in the Buck Creek Cotton Mill Company map of N $\frac{1}{2}$ of NW $\frac{1}{4}$ Section 11, Township 21, Range 3 West, prepared by H. A. Turner, Engineer, and

WHEREAS, Siluria Mills, Inc. desires to and now therefore, does hereby declare the following described portions of streets and alleys vacated. Said streets and alleys being described as follows:

1. Cotton Street from its intersection with Centre Avenue run in a northerly direction until it intersects the south line of Thompson Avenue.
2. That part of a certain 10' alley running north and south through the center of Block 5 where it begins at the south line of Centre Avenue and extends southerly for 139.03 feet.
3. All of Mill Street as shown on said Map.
4. Centre Street from its intersection with the east line of an unnamed alley running north and south through Blocks 3 and 4 and extend west to its intersection with Company Street.
5. All of Thompson Avenue as shown on said Map.

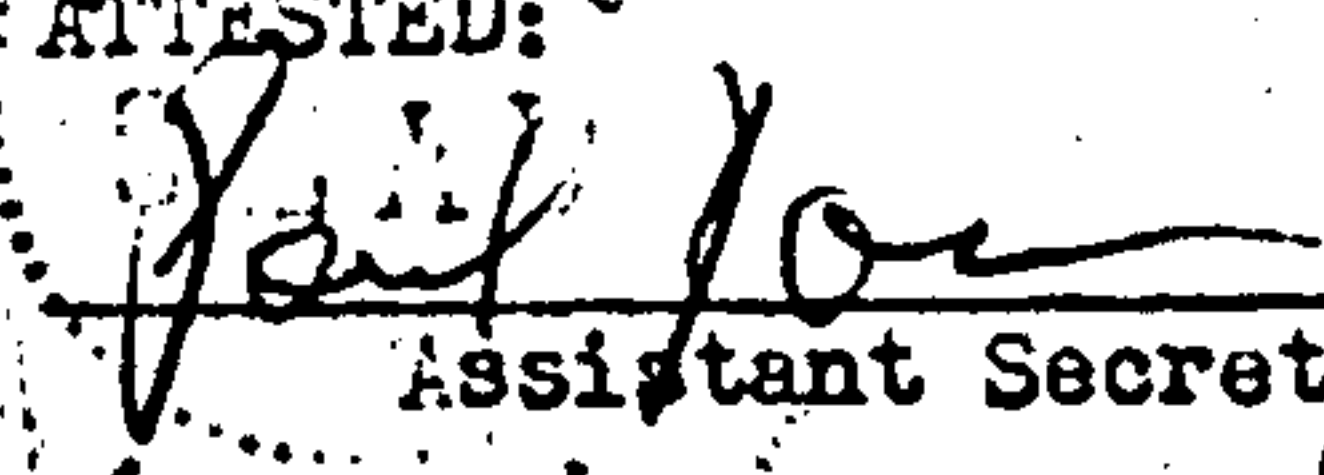

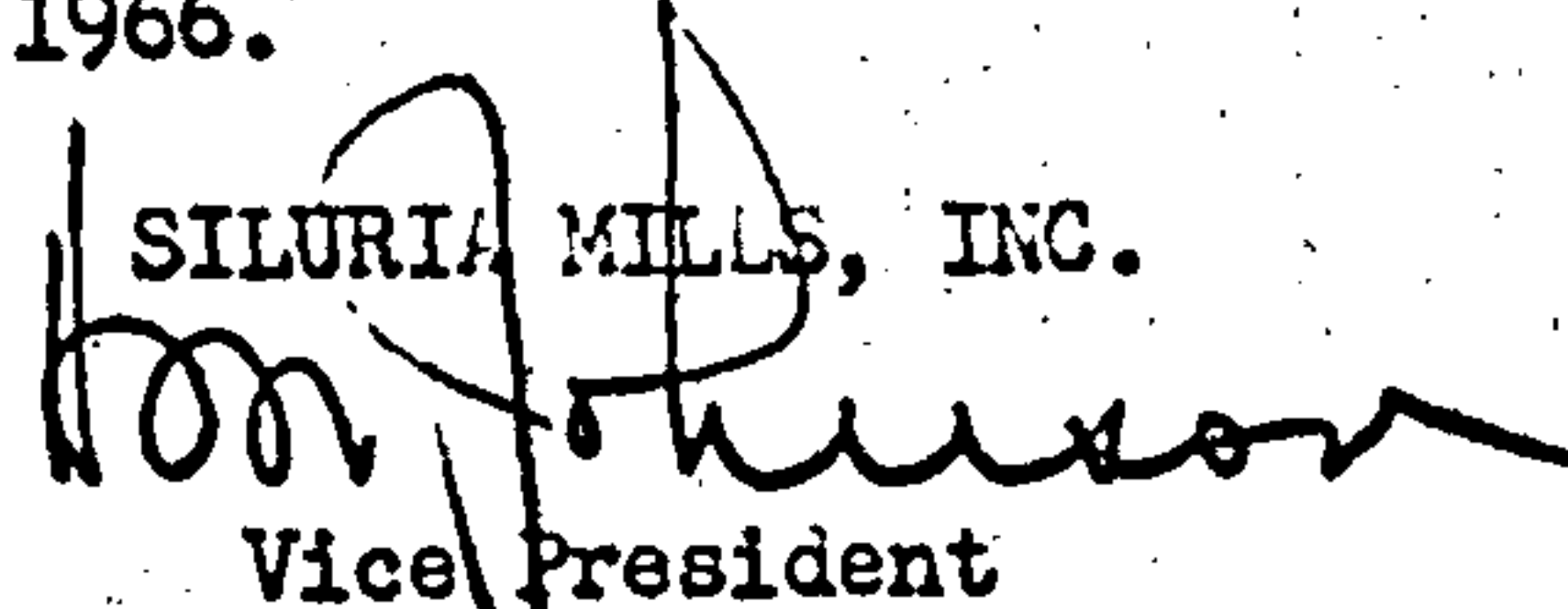

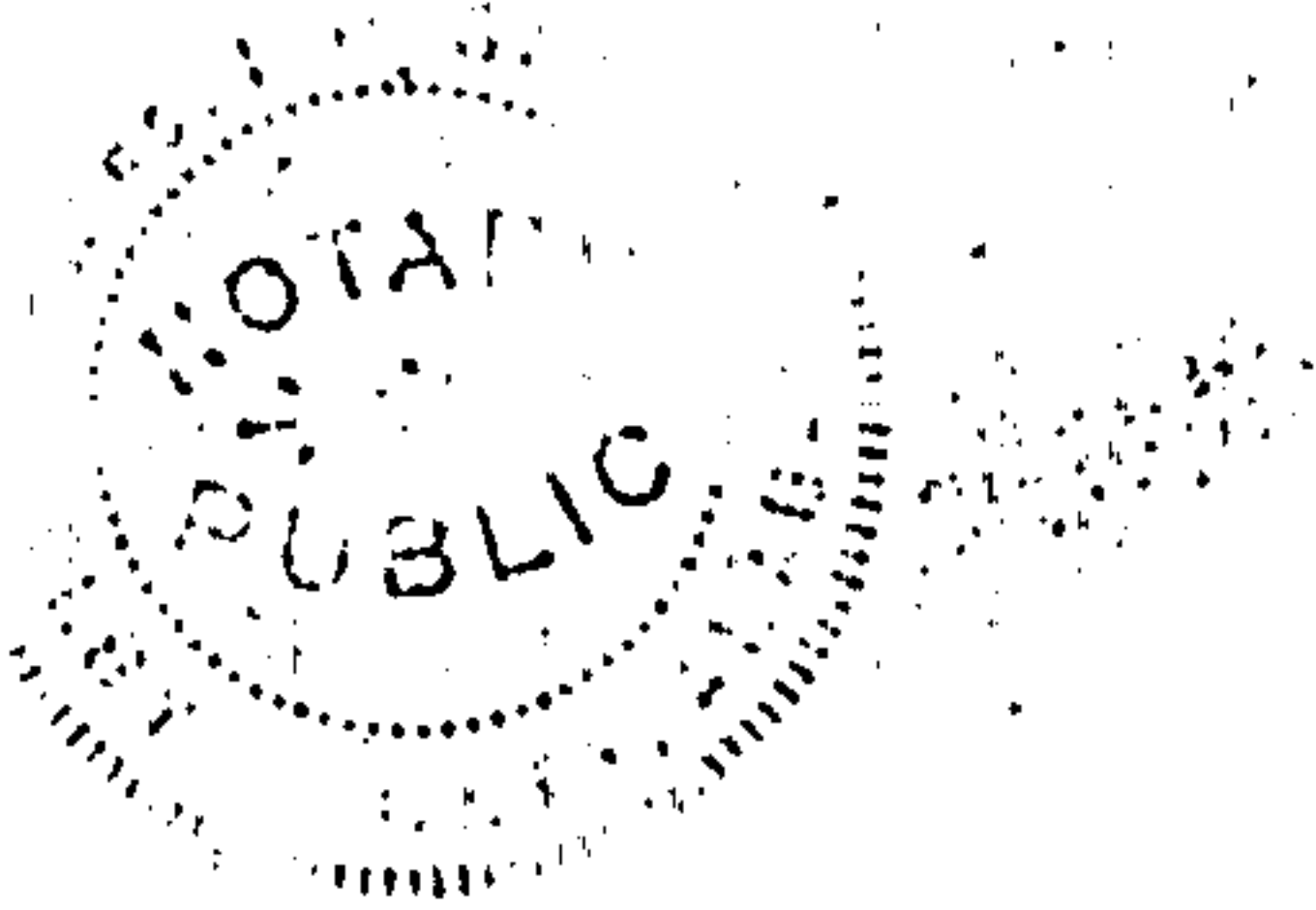

MINUTES OF SPECIAL MEETING OF THE MAYOR AND
TOWN COUNCIL OF THE TOWN OF SILURIA

A call meeting of the Mayor and Town Council of the Town of Siluria, Alabama, was held in the office of the Town Clerk in the Town of Siluria, Alabama on the 20th day of January, 1966, at 4:30 o'clock P.m. and there were present at said meeting the Mayor and the following councilmen: Charles Adams, Willie Brogden, Earl Duke and Bascom Vinzant. Absent: Councilman Carl Davenport.

The said meeting having been specially called for the purpose of passing a resolution giving the assent of the Mayor and Town Council for the vacation of certain streets and alleys as shown on the Buck Creek Cotton Mill Company Map of N $\frac{1}{2}$ of NW $\frac{1}{4}$, Section 11, Township 21, Range 3 West, prepared by H. A. Turner, Engineer and recorded in Map Book 3 page 8 in the Probate Office of Shelby County, Alabama, as shown by a petition filed by Siluria Mills, Inc., and each of the members of the Council having waived notice of said meeting, which waiver is in words and figures as follows:

BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF SILURIA, ALABAMA, AS FOLLOWS:

Whereas, Siluria Mills, Inc. has filed a petition requesting the Mayor and Town Council to give their consent for the vacation of certain streets and alleys within the Town of Siluria, as shown by said petition; and, whereas, the Mayor and Town Council desire to give their assent for said streets, avenues and alleys hereinafter described in detail to be vacated.

Now, therefore, be it resolved by the Mayor and Town Council of the Town of Siluria, Alabama, that the Mayor and Town Council give their assent and do hereby give their assent, for the vacation of the following described portions of streets, avenues and alleys, to wit:

The following described streets, avenues and alleys as shown on map of Buck Creek Cotton Mill Company prepared by H. A. Turner, Engineer, and which is recorded in Map Book 3 page 8 in the Probate Office of Shelby County, Alabama;

1. Cotton Street from its intersection with Centre Avenue run in a northerly direction until it intersects the south line of Thompson Avenue.

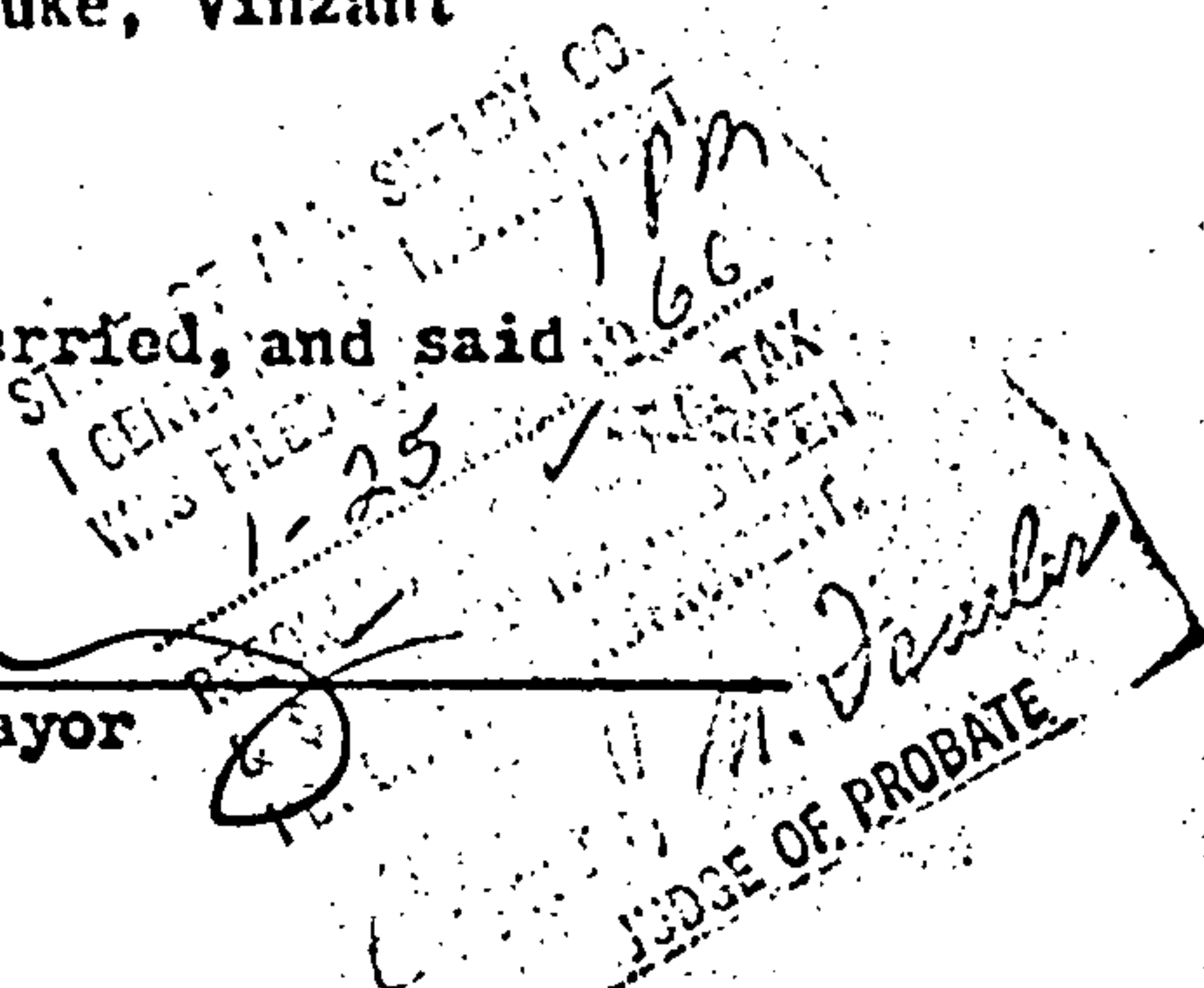
