
KNOW ALL MEN BY THESE PRESENTS:

That, WHEREAS, by deed dated November 30, 1959, and recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Volume 206, at page 242, Buck Creek Cotton Mills, a corporation duly organized and existing under the laws of the State of Alabama, did convey to Siluria Mills, Inc., a corporation organized and existing under the laws of the State of Alabama, certain real properties situated in Shelby County, Alabama, as particularly described in Schedule A attached to said deed, and

WHEREAS, Buck Creek Cotton Mills subsequently amended its certificate of incorporation so as to change its name to Buck Creek Industries, Inc. and said Buck Creek Industries, Inc., as successor by change of name of Buck Creek Cotton Mills and Siluria Mills, Inc. desire to correct said erroneous description by the execution, delivery and acceptance of this deed.

NOW THEREFORE IN CONSIDERATION OF THE PREMISES, and for the purpose of correcting said former deed hereinabove described, Buck Creek Industries, Inc. does hereby grant, bargain, sell and convey unto Siluria Mills, Inc. the following described real property subject, however, to the lien of that certain purchase money mortgage executed by the grantee herein to the grantor herein as corrected by mortgage deed of correction of even date herewith, viz:
