DEED OF CORRECTION

KNOW ALL MEN BY THESE PRESENTS:

That, WHEREAS, Buck Creek Cotton Mills, a corporation organized and existing under the laws of the State of Alabama, did by deed dated October 30, 1950, and recorded in the Office of the Judge of Probate of Shelby County, Alabama, at Volume 206, page 251, convey to H. M. Johnson certain real property situated in Shelby County, Alabama, as particularly described in said deed, and

WHEREAS, by amendment to its certificate of incorporation, Buck Creek Cotton Mills has changed its name to Buck Creek Industries, Inc. and said Buck Creek Industries, Inc. as successor to Buck Creek Cotton Mills and H. M. Johnson are desirous of having the same corrected by the execution and delivery of this deed;

NOW THEREFORE IN CONSIDERATION OF THE PREMISES, Buck Creek Industries, Inc. does hereby grant, bargain, sell and convey unto H. M. Johnson the following described real property situated in Shelby County, Alabama, viz:

Part of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ and part of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 2, Township 21 South, Range 3 West; more particularly described as follows:

Commence at the Southeast corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 2, Township 21 South, Range 3 West; thence run North along the East line of said quarter-quarter Section for 1324.33 feet to the Northeast corner of said quarter-quarter Section; thence 146 degrees 52'15" left and run Southwesterly 340.00 feet to the point of beginning; thence continue Southwesterly along the same course for 262.00 feet; thence 90 degrees right and run Northwesterly 694.29 feet to a point on the Southeasterly right of way line of Alabama Highway #119; thence run Northeasterly along said right of way line for 277 feet more or less; thence run Southeasterly and parallel with the Southwest line of said parcel 608 feet more or less, to the point of beginning.

TO HAVE AND TO HOLD unto the said H. M. Johnson, his
heirs and assigns forever.
