Weldon L. Hawkins and Ida Mae S. Hawkins

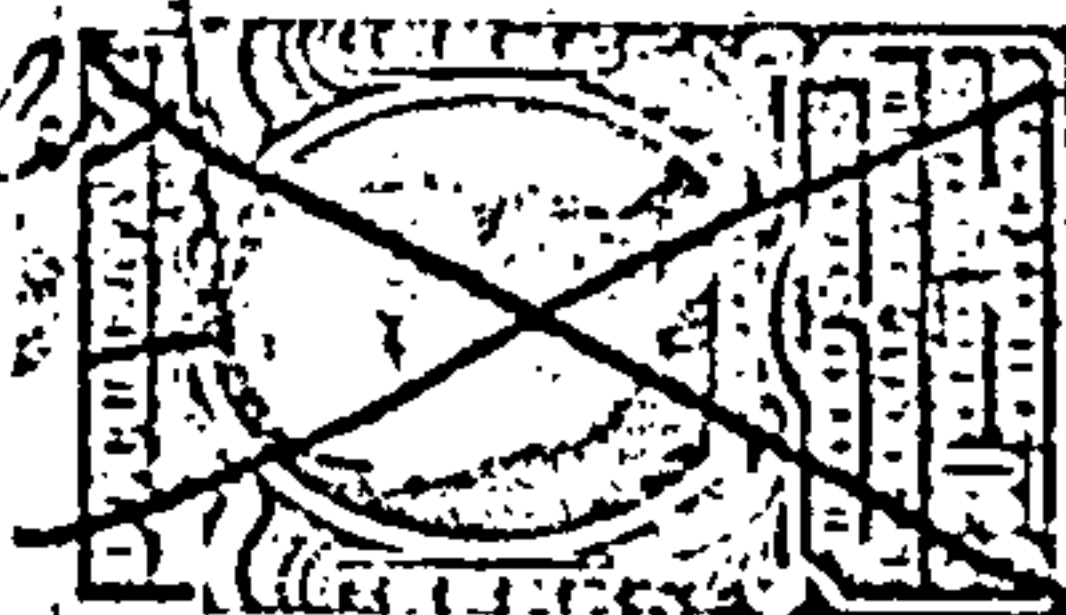
