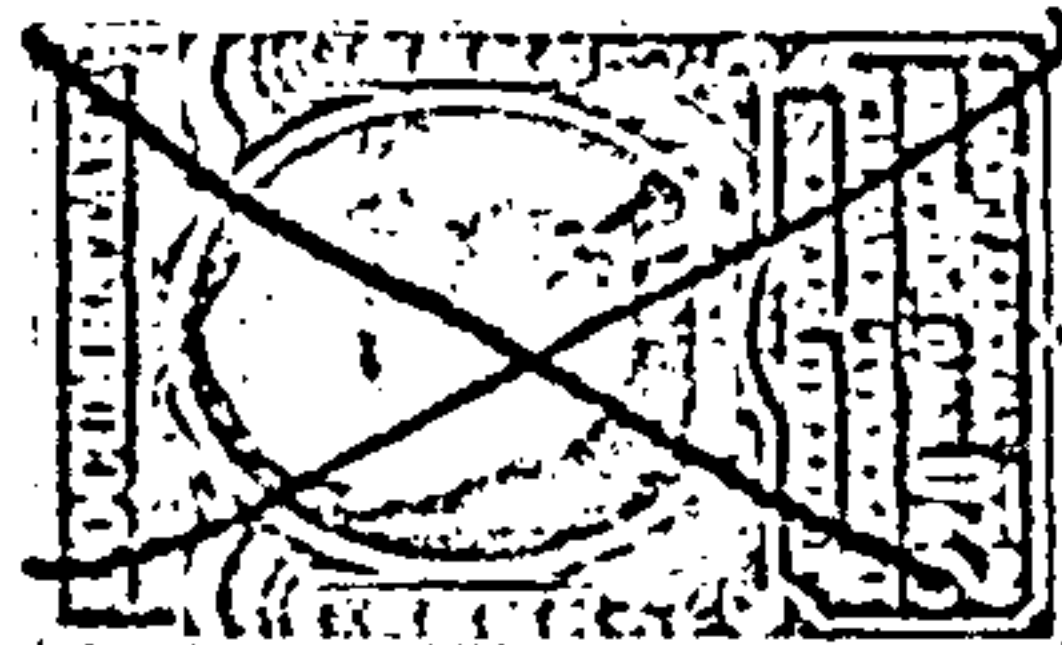
William T. McCartney and Cordelia N. McCartney

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in **Shelby County, Alabama, to-wit:**

Lot No. 20 as shown on a map entitled "Property Line Map, Siluria Mills" prepared by Joseph A. Miller, Reg. Civil Engineer on October 5, 1965, and being more particularly described as follows:

Commence at the intersection of the southerly right of way line of 4th Avenue West and the westerly right of way line of Cotton Street, said right of way lines as shown on the map of the Dedication of the Streets and Easements, Town of Siluria, Alabama; thence southwesterly along said right of way line of 4th Avenue West for 170.69 feet; thence 74 deg. 41 min. left and run southerly for 55.68 feet to the point of beginning; thence continue southerly along last stated course for 97.00 feet; thence 88 deg. 44 min. 15 sec. left and run easterly for 179.00 feet to a point on the west line of Cotton Street; thence 91 deg. 15 min. 45 sec. left and run northerly along said right of way line of Cotton Street for 60.00 feet to the beginning of a curve to the left, said curve having a radius of 707.92 feet; thence northerly along the arc of said curve and along said right of way line of Cotton Street for 37.00 feet; thence 85 deg. 43 min. 50 sec. left from tangent of aforementioned curve and run westerly for 178.03 feet to the point of beginning.
